### Conditions for Use:

- (1) Access to AMA Content will not be granted until the Requestor has completed and signed the Research Agreement (the “Agreement”), and it has been signed by American Medical Association (AMA) staff.
- (2) With this Agreement the AMA grants the Requestor access to its records and AMA Content for scholarly purposes only, including review, reference, analysis, and allows for citation or limited quotation in a published work, and according to “fair use” copyright principles. Requestor will not reproduce or let others reproduce its research and AMA Content, except as noted in the “Intended Use” section above. The Requestor agrees to submit a separate request for an agreement for extensive quoting or excerpts from textual records, and for reproduction and use of copyrighted text, images and audiovisual recordings that will appear in a published work.
- (3) Payment in advance is required for materials delivery and copy services, as designated by the AMA.

(4) Proper and complete citation of AMA Content in research and published works is required. Copyright notices must also appear on the same page as the reference, or at the end of an audiovisual work, as follows:

- If AMA holds copyright: “© American Medical Association, [insert date of first publication as designated on the AMA Content]. All rights reserved./Courtesy AMA Archives”
- If AMA holds item, but not copyright: “Courtesy American Medical Association Archives”

(5) Upon completion, a copy of your work must be sent to the AMA at no charge, to the attention of the AMA Archives, Office of the Director, Allen Podraza.

(6) The Requestor may request photocopies of textual records or reproductions of images or audiovisual records to assist research. **These copies are for personal reference only**, and may not be reproduced, modified, published or distributed in any way. Onsite researchers may use digital cameras and scanners to capture up to 50 images per day of research, subject to these same restrictions. Permission to copy or scan may be denied based on condition of material. Requestors may be asked to maintain a record of files from which digital images are taken, and provide these records to the AMA, upon request.

(7) In authorizing the Requestor’s use of records and AMA Content, the AMA retains all ownership rights and interest in the AMA Content including copyright unless otherwise specified in the AMA Content. The AMA does not surrender any of its own rights to use, reproduce, publish or distribute materials from its archival collections, or to grant permission to others to do so.

(8) Permission to use AMA Content in the AMA Archives does not imply an endorsement by the AMA or AMA Archives of the Requestor’s views or opinions, or the views or opinions expressed in the Requestor’s work (i.e.: research paper, thesis, article, documentary, etc.). In addition, no part of the AMA Content may be commercialized, sold, licensed, or used as a supplement to advertising or promotion, either by attachment or enclosure.

(9) The Requestor acknowledges that records in the AMA Archives may not represent current opinion of the AMA.

(10) The AMA makes no representation of exclusive ownership of the rights to images or other records not produced by the AMA. The AMA simply grants permission to reproduce from such images as are in its collections. The Requestor assumes all responsibility for complying with all laws related to the use of the AMA Content.

(11) The AMA may terminate this Agreement immediately upon notice to Requestor if Requestor violates any of the Conditions for Use. All rights to use and/or distribute AMA Content shall immediately cease upon termination.

(12) This Agreement shall only be effective upon execution by the AMA.
