Research Initiative to Sponsor and Empower Women in Medicine and Science

While there is an increased number of women in the U.S. physician workforce, little has been done to address the complex issues of their marginalization and lack of career advancement. One of the critical challenges that women physicians face is lack of opportunities for growth in research, which is one of the key criteria for promotion in academic medicine.

In the program, Research Initiative to Sponsor and Empower Women in Medicine and Science (RISE WIMS), researchers aimed to explicitly address these structural barriers by providing a formal research sponsorship program, in which women physicians were formally invited to existing research projects or given the opportunity to initiate a new project with a sponsor's support.
