2018 Specialty Society Delegate Apportionment

This year delegates from national medical specialty societies are apportioned under new rules that will provide them with the same overall number of delegates as constituent societies. The ballot system has been abandoned; each national specialty society will (in most cases) be apportioned delegates on the basis of the number of AMA members in the society at its most recent five-year review. The 2018 delegate apportionment is based on official AMA membership records.

Policy G-600.027, "Designation of Specialty Societies for Representation in the House of Delegates," sets out the rules implementing Bylaw 2.2 to determine each specialty society's delegate apportionment. Constituent societies have been apportioned 271 delegates for 2018 (not including two delegate slots for the speakers per bylaw 2.5). Consequently, 271 delegates were apportioned across the 117 national medical specialty societies in the House and the five additional specialty societies expected to be admitted in June, societies that the Specialty and Service Society has determined meet the criteria.

Every society seated in the House of Delegates is entitled to one delegate, but the following 43 national specialty societies have more than one delegate (with a like number of alternate delegates):

Remaining national medical specialty societies, including those expected to be seated in June, are each apportioned one delegate (and one alternate) for 2018. The net result is that there will be 271 specialty society delegates this year. Delegate apportionment figures for all specialty societies appear in the 2018 Specialty Society Delegate Apportionment table accompanying this memo.

Specialty societies with more than one delegate are generally seated as a unit. For those societies newly apportioned more than one delegate, this will be a change, as one person specialty delegations have historically been seated in the House with the delegate's home state. However, it is also true that over the last few years, many specialty societies have chosen to be seated together as a group, and societies are welcome to form new groups or join an existing group. Seating charts can be found in any recent Handbook, or contact Roger Brown or Patti Wargo in the House of Delegates office (contact information below). Requests for seating arrangements must be submitted no later than April 2, 2018.

Rosters of delegates and alternate delegates are maintained by the Office of House of Delegates Affairs, and the current listings can be viewed at *ama-assn.org/2018-delegation-rosters* (login required). In light of the new rules for apportioning specialty society delegates, 54 new delegates will be named. Those new names along with corrections or changes should be sent by March 16, 2018 to:

This will ensure that your society's delegates and alternates receive information about this year's House of Delegates meetings. Be sure to include an email address for each individual, as most House-related communications are electronic. No action is required at this time if all your delegates and alternate delegates are listed and their contact information is correct.

Please note that these requested roster updates are distinct from the credentialing process that takes place before each meeting. Under AMA bylaws, (§2.2.4) delegates and alternate delegates must be certified before *each* meeting. For the Annual Meeting, you can expect the certification process to begin in late-March, after roster updates have been applied.

Please ensure that your delegates and alternate delegates have renewed their AMA memberships for 2018. AMA bylaws specify that all delegates (§2.0.1.1) and alternate delegates (§2.8.1) must be AMA members, and individuals who are not members will not be included on a delegation roster. You will be notified of any discrepancies.

You might also wish to check the pictorial directory at https://pictorialdirectory.ama-assn.org to review your delegation's listing and note those delegates for whom photos are missing or outdated. The pictorial directory is only as good as it is current, and your help in ensuring its completeness would be greatly appreciated. New photos should be sent to Patti Wargo either electronically (patti.wargo@ama-assn.org) or in hard copy.

Several specialty societies have endorsed resident and fellow sectional representatives (§2.4 of the bylaws) and are listed in a second table below. The delegate numbers above and in the Specialty Society Delegate Apportionment table do not include these resident and fellow sectional delegates, but allowance will be made to seat them with their endorsing societies. Societies are urged to make every effort to include these delegates and alternate delegates in pertinent activities and communications.
