Resolution 1: Putting Price Transparency Into Practice Introduced by Erick Eiting, MD and John Vasudevan, MD	Adopted as Amended RESOLVED, That our AMA study appropriate mechanisms through which patients will be able to obtain price data from providers, facilities, insurers and other health care entities prior to the provision of non-emergent services, and that the AMA study the barriers to this goal and serve as a leading voice in this discussion (Directive to Take Action); and be it further RESOLVED, That our AMA support medical education efforts to enhance cost transparency as a part of undergraduate and graduate medical education, focused on the cost of the tests providers order, as well the cost of durable medical equipment and facility fees (Directive to Take Action); and be it further RESOLVED, That our AMA provide regular updates to its membership on the path toward enhancing the transparency of cost within the U.S. health care system for both providers and consumers, and how the AMA can be the leading voice in this effort (Directive to Take Action). RESOLVED, That this resolution be immediately forwarded for consideration during the 2013 Interim meeting of the AMA House of Delegates (Directive to Take Action).
