Interested party requests will be processed within 5 days of receipt of the requested forms. Commenters will follow the deadline instructions in the correspondence provided by AMA staff. The deadline for request to review any non-Pathology/Laboratory code change applications is **September 7, 2018**. The deadline for submission of written comments for non-Pathology/Laboratory applications is **September 14, 2018**.
