

My vision for the Medical Student Section is for it to be an environment that involves, unites, and empowers you. If elected as your Vice Chair, I will work towards that vision and do everything in my capacity to eliminate barriers to involvement and to fortify the work of our standing committees. I want to enhance your AMA experience with intentional support no matter what your level of experience or involvement.

Dear AMA-MSS members,

My name is Baillie Bronner and I am running to be the next Vice Chair of the AMA-MSS. My priorities will be to maintain the spirit of the medical student section by investing in you through mentorship programs, informing you in ways that are already part of your workflow, and enabling you to most effectively impact the wellbeing of our patients.

During my first year of medical school, a friend of mine told me that I could have a free trip to Chicago if I agreed to be part of the leadership for our school's AMA group. I took her up on that offer and attended my first AMA meeting at Annual 2017. At the first meeting, our region leadership walked us through the list of resolutions, and I sat there feeling pretty overwhelmed and a bit embarrassed to be feeling so clueless. Despite the rocky beginning, by the end of the meeting I felt better informed and encouraged. Over the few days of hearing testimony from students during the assembly, I realized that the AMA was an avenue for me to contribute to effective change in healthcare. The seemingly permanent issues that not only affected my medical education but also the wellbeing of my future patients were not only being discussed, but also acted upon.

In addition to my continued involvement at UNM, I became a member of the standing committee on Health Information Technology (CHIT). Through CHIT, I found others within the MSS who I connected with over our shared interests in health IT. We collaborated on projects I never could have taken on alone and empowered each other at every step of the way. As Vice Chair of that committee, I found a sense of purpose and excitement when organizing and channeling the passions of my committee members into collective action, specifically through reports and resolutions. Each unique committee serves to carry out the vision of the MSS by writing reports, reviewing resolutions, creating content, and programming engagement events. The Vice Chair's primary roles are to oversee these committees and to be their loudest advocate with the MSS governing council. I am running for Vice Chair because I find fulfillment in being an ally in growth and this year, I hope to do that for our standing committees and the larger AMA- MSS.

While productivity is inevitably lost with turnover of members each year, robust mentorship and leadership development can help to minimize this loss. Furthermore, excellence in report writing, content creation, and resolution crafting can only happen if we deliberately invest in our members. If elected your Vice Chair, I will help cultivate the next generation of student leaders by creating a comprehensive leadership on-boarding process. Newer committee leaders will be connected to experienced members who can direct training and serve as mentors. Standing Committee leadership meetings will focus on development of transferable leadership skills and be formatted as small group break-outs to enable more efficient mentorship and committee collaborations. Within committees, our priority will be to mentor members by giving them the guidance that they need to lead meetings and projects.

In such a large organization, information can be particularly hard to find. Deadlines, applications, and submission forms are often in scattered locations and work that standing committees do can often go unnoticed. If elected your Vice Chair, I will seek to maximize efficiency in communication through the use of a global shared calendar and multiple synchronous social media platforms. This way, standing committees and AMA-MSS members will be well informed about important deadlines, ventures within the MSS, and opportunities for increased involvement.

Each year the AMA-MSS writes quality resolutions, but the process continues to be challenging to navigate for so many of us. If elected Vice Chair, I will work closely with our Section Delegates to facilitate early collaborations between resolution writers and standing committees that are well-versed on their topic of interest. Through early collaboration, authors can spend more time on the content of the resolution with a point person to help them navigate the logistics of writing a strong resolution. Facilitating these connections will also allow for channeling of similar interests to members who sit on the House Coordinating Committee, ensuring that we are best prepared at the House of Delegates to speak clearly and loudly on issues that matter most to us.

I want to thank all of the standing committee leaders, region leaders, and student members who took the time to help me understand how I can best serve the role of Vice Chair. I am excited to be running for Vice Chair of the AMA-MSS at Annual 2019 and would be honored to have your vote!

Ms. Bronner has served as the UNM AMA Vice President and recruiter since her first year of medical school. 

Like many others in the MSS, I became involved in organized medicine during my first year of medical school. I had always had a strong interest in politics, but had never been given the opportunity to become more involved. And while I felt that I had little experience to demonstrate why I should become my school's co-president, I wrote an impassioned application detailing my enthusiasm and my willingness to put in any and all work necessary. Thankfully, the co-president's ahead of me looked past my lack of experience and gave me a chance. I still remember receiving the call that I had been selected for the position while walking around a Marshall's and shopping with my wife.

She began to immerse me in the AMA and encouraged me to run for the AMA Foundation Student Ambassador regional position during my first region business meeting. Ever since, I have been actively applying to various positions within the AMA in order to accomplish two goals.

First, I wanted to become involved at various levels and in various formats in order to gain a broader grasp on how the AMA functions. Between standing committees at the regional and national level, regional leadership, and the AMA Foundation, I have worked with many people across the country and have benefited from participating in different leadership styles and working within multiple group dynamics.

Secondly, I wanted to become really proficient at understanding all of the different facets of the policy process. Initially, this began by writing my own resolution regarding the rights of Transgender individuals to use the bathroom matching their gender. I took this resolution through every stage of the process; from the various drafting stages in the MSS, to defending it on the floor, working with GMLA and the APA to prepare for the House of Delegates. And while I found immense joy in having my resolution become AMA policy, I found during my experiences that helping others to perfect their own policies was even more stimulating. For those of you who haven't had the chance, I highly encourage you to stay during the House of Delegates portion of the AMA meeting. During that part of the meeting the entire MSS comes together for a common purpose of advancing the will of the MSS. The 60-80 or so students who band together are instrumental in coordinating testimony, communicating with various professional organizations, and ultimately convincing the members of the HOD that our progressive agenda isn't really all that progressive and would be of great benefit to our patients. Orchestrating this beautiful symphony of advocacy is our Section Delegate and Alternate Delegate.

There is no doubt that our section delegates have a difficult job – it's both time consuming and logistically challenging. However, I believe I am up to the challenge. As Vice Chair of the House Coordinating Committee over this past year, I have really figured out how to manage time, plan ahead, and communicate effectively and efficiently with my teams all while under the constraints that come with being a third year medical student on clinical rotations. Over the next year, I have planned out my schedule such that I should have ample time to devote to this position.

The last thing I want to share with you all is a wonderful quote I recently heard while watching the Brené Brown Netflix stand-up special. Her special details some of the work she has done around courage and shame. And while she focused on courage in everyday life, I found that it paralleled well with the philosophy that underpins how to best utilize the political capital of

the MSS. During her special, she quoted Teddy Roosevelt - "It is not the critic who counts; not the man who points out how the strong man stumbles, or where the doer of deeds could have done them better. The credit belongs to the man who is actually in the arena, whose face is marred by dust and sweat and blood; who strives valiantly; who errs, who comes short again and again, because there is no effort without error and shortcoming".

Most of the time, the MSS brings policy to the HOD that is a so-called "easy-ask". These are policies that highlight underserved populations, address hot topics like mental health, etc. Those resolutions don't require a lot of political capital. However, as one can expect with our generation, we like to bring policy forward that challenges the status quo and makes the generation ahead of us uncomfortable. It is during these situations where our MSS caucus discussions often center around our political capital. It is my opinion that we really need to be "in the arena" for these high impact, controversial policies. And thanks to the many section delegates prior, our MSS has built up a lot of respect and political capital in the House of Delegates. This has been accomplished through years of organization, preparation, consistency, and respectful behavior during the meetings. I plan to continue setting this high bar for our delegates and alternate delegates so that we can be politically aggressive when it comes to adopting our agenda.

I want to thank everyone for their consideration and look forward to the opportunity to serve the MSS as your Section Delegate.



Near peer mentorship is paramount to the goal of teaching AMA policy. As my Region's Policy Chair, I recruited our RD/ADs and other experienced members to encourage first-time authors and facilitate our Region's review of MSS resolutions. In addition to hosting Region-wide policy events, I created and distributed a [Policy Writing Workshop "toolkit"](#) to make it easier for students to deploy their own trainings locally.

I believe in leveraging the expertise and leadership within our community to proactively engage newer members on a personal level. **This increases familiarity with the policy process, gives students early exposure to institutionalized knowledge, and promotes close relationships with experienced peers.** As your Delegate, I will work closely with the appropriate policy leaders in each Region to develop similar mentorship networks across the Section. Each Region operates differently, but all will gain from sharing our best practices, suggesting new policy activities, and distributing materials.

INNOVATION

BUILD MSS POLICY FINDER: SEARCHABLE DIGITAL COMPENDIUM OF MSS POLICY AND ARCHIVED KNOWLEDGE

Successful policy-writing depends on being able to access institutional memory to ensure that a resolution idea is novel, procedurally appropriate and politically viable. Thanks to AMA PolicyFinder, the AMA's online policy search tool, relevant HOD policy is easy to locate. In contrast, the MSS Policy Digest is contained in an unindexed PDF that has swelled to a massive 194 pages, making it difficult to browse and search. Compounding this is the fact that although the MSS is dutiful about recording debate at HOD and archiving important meeting documents (e.g. Council reports), these pieces of information are spread across multiple tech platforms and are neither accessible nor actionable. In an organization as complex and opaque as the AMA, we can't expect our authors to incorporate information they cannot find. I believe strongly that the MSS can craft a easily accessible digital compendium for the benefit of all members.

At bitly.com/msspolicyfinder, you can find a video demo of a prototype “MSS PolicyFinder” I’ve built to prove this point. Imagine a web app that not only makes it easier to browse the MSS’s policy, but that allows filtering for external vs. internal policies, highlights items with pending action in the HOD, and provides links to important documents related to the policy of interest. As my demo shows, we could build and maintain such a tool with resources already available to the Section. If elected, I will work with your new GC to convene a task force aimed at developing and implementing a version of this tool that meets the various needs of our authors, policy analysts, and delegates.

PARTNERSHIP

PROMOTE POLICY COLLABORATIONS WITH URM STUDENT GROUPS

The MSS consistently leads the AMA in acknowledging social determinants of health of and asserting their relevance to Organized Medicine. However, we are not immune to the lack of racial and socioeconomic diversity that characterizes the AMA and medical school classes across the country. There will never be a replacement for actual representativeness in our membership, but we can do more to ensure that the policies we pass address the needs of populations that are underrepresented in medicine (URM).

This past year, your Chair has done an incredible job of building bridges between the MSS and URM medical student groups such as the Student National Medical Association, Latino Medical Student Association, and others. Some of these groups do not contain policy-making bodies and have expressed interest in promoting coordination between our chapter members. As your Delegate, I will work with your new Chair and GC to capitalize on this progress by reaching out to the leadership and bilaterally encouraging our chapters to conduct joint policy events. New perspectives will enrich the impact and relevance of our advocacy and further strengthen the voice of medical students in health policy reform.




