AMA GME Initiative Goals

Transform residency training to best address the workforce needs of our current and future health care system.

- Preserve continuity in training
- Ensure readiness for entry into practice
- Support well-being for trainees, mentors, and colleagues




AMA GME Initiative Framework

- Build on format of successful AMA/ACE UME initiative
- RFP process to select eight recipients for pilot projects
- Applications from medical schools, GME programs, GME sponsors, health systems
 - Emphasis on collaboration
- Selection via established criteria and national advisory panel
- Funds will be awarded for a 5-year cycle with contracts for annual objectives and measurable outcomes
- Selected institutions will join the existing Accelerating Change in Medical Education consortium, adding GME innovation to this collaborative effort




RFP response

- 252 Letters of Intent received
 - 300+ entities with oversight of GME in the U.S.
 - 130+ medical schools
 - 94% of ACE consortium schools represented
 - Specialty societies, associations and health systems
