RESOLUTIONS

1. Patient Medical Marijuana Use in Hospitals Introduced by the Oklahoma State Medical Association OMSS

OMSS Action: Alternate resolution adopted in lieu of Resolution 1:

PATIENT MEDICAL MARIJUANA USE IN HOSPITALS

RESOLVED, That the OMSS Delegate be instructed to support the intent of AMA Resolution 414-A-19, Patient Medical Marijuana Use in Hospitals, and seek referral with report back at the 2019 Interim Meeting.

HOD Action: Resolution 414 referred but without a date certain report back.

2. Military Physician Reintegration into Civilian Practice Introduced by Massachusetts Medical Society OMSS

OMSS Action: Resolution 2 adopted as amended and transmitted to the AMA House of Delegates for consideration at the 2019 Annual Meeting:

RESOLVED, That our American Medical Association develop recommendations to inform local credentialing bodies of pathways to facilitate the process for military veteran physicians and surgeons to return to civilian practice without compromising patient care.

HOD Action: Alternate resolution adopted in lieu of Resolution 717:

REENTRY INTO PHYSICIAN PRACTICE

RESOLVED, That our American Medical Association encourage hospitals to establish alternative processes to evaluate competence, for the purpose of credentialing, of physicians who do not meet the traditional minimum volume requirements needed to obtain and maintain credentials and privileges; and be it further

RESOLVED, That our AMA encourage The Joint Commission and other accrediting organizations to support alternative processes to evaluate competence, for the purpose of credentialing, of physicians who do not meet the traditional minimum volume requirements needed to obtain and maintain credentials and privileges.

3. EHR-Integrated PDMP Rapid Access Introduced by Massachusetts Medical Society OMSS

OMSS Action: Resolution 3 adopted and transmitted to the AMA House of Delegates for consideration at the 2019 Annual Meeting:

RESOLVED, That our American Medical Association advocate, at the state and national levels, to promote Prescription Drug Monitoring Program (PDMP) integration/access within Electronic Health Record workflows (of all developers/vendors) at no cost to the physician or other authorized health care provider.

HOD Action: Resolution 244 adopted.

4. Restrictive Covenants of Large Health Care Systems Introduced by Medical Society of the State of New York OMSS

OMSS Action: Resolution 4 adopted as amended and transmitted to the AMA House of Delegates for consideration at the 2019 AMA Annual Meeting:

RESOLVED, That our American Medical Association, through its Organized Medical Staff Section, educate medical students, physicians-in-training, and physicians entering into employment contracts with large health care system employers on the dangers of aggressive restrictive covenants, including but not limited to the impact on patient choice and access to care; and be it further

RESOLVED, That our AMA study the impact that restrictive covenants have across all practice settings, including but not limited to the effect on patient access to health care, the patient-physician relationship, and physician autonomy, with report back at I-19.

HOD Action: Resolution 026 adopted.

5. Abuse of Volume Based Metrics Introduced by Pennsylvania Medical Society OMSS

OMSS Action: Alternate resolution 5 adopted in lieu of Resolution 5 and transmitted to the AMA House of Delegates for consideration at the 2019 AMA Annual Meeting:

ECONOMIC DISCRIMINATION IN THE HOSPITAL PRACTICE SETTING

RESOLVED, That our American Medical Association actively oppose policies that limit a physician's access to hospital services based upon the number of referrals made, the number of procedures performed, the use of any and all hospital services or employment affiliation.

HOD Action: Resolution 718 referred.

6. Gender Equity in Hospital Medical Staff Bylaws Introduced by OMSS Governing Council

OMSS Action: Resolution 6 adopted and transmitted to the AMA House of Delegates for consideration at the 2019 Annual Meeting:

RESOLVED, That our American Medical Association affirm that hospital medical staff bylaws should promote, and not impede, gender equity in their implementation; and be it further

RESOLVED, That our AMA study existing hospital medical staff bylaws as to how they impact on issues of gender equity, directly or indirectly, and suggest any addition(s) to its model bylaws to assure this issue is properly addressed, and gender equity affirmed.

HOD Action: Resolution 025 adopted.

7. Sensible Appropriate Use Criteria In Medicare Introduced by Massachusetts Medical Society OMSS

OMSS Action: Resolution 7 adopted as amended and transmitted to the AMA House of Delegates for consideration at the 2019 Annual Meeting:

RESOLVED, That our AMA Policy H-320.940, "Medicare's Appropriate Use Criteria Program," be amended by addition as follows:

Our AMA will continue to advocate to delay the effective date of the Medicare AUC Program until the Centers for Medicare & Medicaid Services can adequately address technical and workflow challenges with its implementation and any interaction between the Quality Payment Program (QPP) and the use of advanced diagnostic imaging appropriate use criteria, and support regulatory change that resolves technical and workflow challenges and/or removes barriers to modifying or aligning the AUC Program and the QPP.

DISABLED PHYSICIAN ADVOCACY FOR PHYSICIANS WITH DISABILITIES

RESOLVED, That our American Medical Association study and report back on eliminating stigmatization and enhancing inclusion of disabled physicians with disabilities including but not limited to:

(1) Enhancing representation of disabled physicians with disabilities within the AMA.

(2) Examining support groups, education, legal resources and any other means to increase the inclusion of physicians with disabilities in the AMA (Directive to Take Action); and be it further

RESOLVED That our AMA identify medical, professional and social rehabilitation, education, vocational training and rehabilitation, aid, counseling, placement services and other services which will enable disabled physicians with disabilities to develop their capabilities and skills to the maximum and will hasten the processes of their social and professional integration or reintegration. (Directive to Take Action); and be it further

RESOLVED, That our AMA support programs that educate physicians with or without disabilities about legal rights of physicians, employees, and patients with disabilities to accommodation and freedom from discrimination.

BOT Report 15 - Physician Burnout and Wellness Challenges; Physician and Physician Assistant 18. Safety Net; Identification and Reduction of Physician Demoralization

OMSS Action: OMSS Delegate instructed to support the intent of BOT Report 15.

HOD Action: BOT Report 15 adopted as amended and the remainder of the report filed.

Recommendation #3 of B of T Report 15 amended to add three points, all of which address

the AMA's current focus on addressing burnout through an organizational (not

personal) focus.

CMS Report 7 - Hospital Consolidation 19.

OMSS Action: OMSS Delegate instructed to support the intent of CMS Report 7.

HOD Action: CMS Report 7 adopted as amended and the remainder of the report filed. AMA is directed

to work with interested state associations to monitor rural, state and regional markets.

20. CMS Report 11 - Corporate Investors

Report DD: OMSS Position on Council on Medical Service Report 8-A-19: Group Purchasing Organizations and Pharmacy Benefit Manager Safe Harbor

OMSS Action: OMSS Delegate instructed to support the intent of the recommendations of CMS Report 8-A-19,

and seek amendment by the addition of a new Recommendation 6 as follows:

6. That our AMA collaborate with medical specialty partners, patient advocacy groups, and other stakeholders to seek repeal of the 2003 Safe Harbor protection to the Medicare Anti-Kickback

Statute for Pharmacy Benefit Managers.

HOD Action: CMS Report 8 adopted as amended with the addition of a new recommendation and the remainder

of the report filed. OMSS recommendation not adopted. HOD adopted a

different recommendation #6 that directs the AMA, via letter, to ask the HHS Secretary to request the HHS Office of Inspector General (OIG) to examine the state of prescription drug purchasing and availability, and expeditiously make recommendations designed to make prescription drugs more accessible and affordable to patients, with a special focus on drugs in short supply and/or that are exceedingly expensive, to ensure compliance with all the safe harbor provisions.
