

**OFFICIAL GAME RULES**  
**AMA ANNUAL MEETING SCAVENGER HUNT, 2019 EDITION ("Game")**

**1. Official Game Rules.**

These are the official game rules ("Official Game Rules" or "Rules") for the AMA Annual Meeting Scavenger Hunt, 2019 Edition. By entering the Game, each individual entrant and each entering team (collectively referred to as "Entrant") irrevocably agrees to be bound by these Rules. Each Entrant also irrevocably agrees to be bound by the interpretations of these Rules by, and decisions of, the Administrator. Decisions of the Administrator are final.

The Administrator may change these Official Game Rules at any time. If the Administrator does change the terms and conditions, the Administrator will post an updated version of the Official Game Rules on the Game website: [ama-assn.org/game-rules](http://ama-assn.org/game-rules). An Entrant's continued use of the Game website or participation in the Game after any changes are made to the Official Game Rules will be deemed to constitute an Entrant's acceptance of those changes. If an Entrant objects to any changes to the terms, the Entrant's only remedy is to discontinue the Entrant's use of the Game website and discontinue participation in the Game.

**2. Game Purpose**

The purpose of the Game is to introduce Entrants to the **AMA Ambassador Program** and to encourage attendees of the 2019 AMA Annual Meeting to interact and network. The Administrator will interpret these Rules to further the Game's purposes as it sees fit.

**3. Scavenger Game Entry Period.**

The Game will begin on noon on Friday, June 7, 2019 and will end at noon, Central Time, on Tuesday, June 11, 2019. Entries must be received at the AMA Booth located at the AMA Annual Meeting space.

**Prizes.**

Each individual member of a winning team will receive a pair of AMA-branded blue tooth earbuds (estimated retail value \$30.00).

In the event a winning team is disqualified or fails to claim the prize, the next team to submit a correctly completed entry for that day will be deemed the substitute winner.

Administrator will not have any further obligation to Entrants or Winners after the award of the Prizes described above. Each Entrant assumes all liabilities associated with entering this Game and the receipt of any Prize. Any Entrant may decline advancement in the Game and decline any Prize prior to its award. Withdrawal from the Game or declining a Prize at any time will nullify an Entrant's designation as a Winner.

**4. How to Enter / How to Win.**

Sign a Waiver and Release Form and Provide an email address

**-Each prospective team member must show his/her identification badge to attend the 2019 AMA Annual Meeting to the staff at the AMA Ambassadors' booth.**

-Each individual Entrant will be required to *sign a Waiver and Release form* to enter (copy of Waiver and Release form is attached to these Rules as **Exhibit A**) and provide an email address.

Form a Team

-Individuals must form a team composed of four (4) AMA 2019 Annual Meeting attendees. **All members of a team must be present together at the same time when registering for the Game.** Only teams of four are eligible to participate. If a team has less than 4 individuals, the staff at the AMA Ambassadors booth will try to find additional team members so every team can participate.

-Each team must have four (4) members and must have no more than 2 from the same state, specialty or section. For example, if a delegate from a specialty society wants to form a team, only one other delegate from that same specialty society can be on the same team.

-Each member of a registered team will receive an Official Entry Form with items to be found or completed.

Hunt, Find and Submit the Specified Items

-Each team must produce or obtain the specified number of items from each of the five (5) columns A through E on the Official Entry Form. A copy of the Official Entry Form is attached to these Rules as **Exhibit C**. Only one team member is required to submit a completed Entry Form.

For example, to submit a completed entry, a team will have to hunt, find and submit

- 3 items from Column A;
- 3 items from Column B;
- 4 items from Column C;
- 3 items from Column D; and
- all 5 items from Column E.

ALL INFORMATION SUBMITTED MUST BE NON-CONFIDENTIAL.

Submit a Team's Completed Entry.

The first four (4) teams to submit a completed entry to the AMA Ambassadors' booth at the AMA Annual Meeting will be the presumptive winners for that day, subject to verification the entries are correct. The confirmed four (4) winning teams will be posted at the AMA Ambassadors' booth. The AMA Ambassadors' booth approximate hours of operation are: 9 a.m. to 5 p.m., Friday to Monday, June 7 – 10, 2019 and 9 a.m. to noon, Tuesday, June 11, 2019.

Only entries by teams are valid.

A team can only enter once. Multiple entries by the same team or the same individuals are not allowed. If an Entrant submits more than one entry (whether under the same or different names), the Administrator at its discretion may disqualify one or all of the Entrant's submissions.

Once an Entrant submits an Entry, the Entrant is prohibited from making substantive changes or alterations to the Entry. No substitutions or materially new versions of an Entry will be accepted under any circumstances once an Entry is submitted.

The first four (4) correctly-completed entries will be the presumptive winners for the day. Each day of the Game there will be 4 different winning teams. Since the Game will run for five (5) days (June 7 through June 11, 2019), there will be a total of 20 winning teams.

**DISABLED ENTRANTS WELCOME:** *If an Entrant is disabled and requires an accommodation to enter or participate, please contact J. Mori Johnson (cell: 773-263-4255; email: [imori.johnson@ama-assn.org](mailto:imori.johnson@ama-assn.org)) as early in advance of the Game Entry Period as possible but no later than Friday, May 31, 2019. With advance notice, alternate tasks will be made available for any Entrants with a disability. The Game shall aim to be as inclusive as reasonably possible.*

**5. Eligibility Requirements**

**Only attendees of the American Medical Association 2019 Annual Meeting are eligible to form teams and enter the Game.** The Game is open only to individuals who are 18 years old or older as of their time of entry.

Employees of the Administrator or its subsidiaries or affiliates (and the immediate and extended family members of said employees) are not eligible to participate in the Game.

**6. Game Boundaries**

While participating in the Game, Entrants should stay within the Game Boundaries. The Game Boundaries are those spaces, during the Game Entry Period (defined in section 3 above), occupied by the 2019 AMA Annual Meeting at the Hyatt Regency Chicago Hotel, 151 East Wacker Drive, Chicago, IL 60601. A map of the Game Boundaries is attached to these Official Game Rules as **Exhibit B**.

**7. Notice to Winner**

Winning teams for each day of the Game will be notified by email at approximately 2 p.m. after each day's entries are received.

**8. General Information**

The Game is subject to all federal, state and local laws and regulations and void where prohibited or restricted by law. If Entrant is employed, Entrant is responsible for abiding by Entrant's employer's policies regarding participation in the Game. The Administrator disclaims any and all liability or responsibility for disputes arising between Entrant and Entrant's employer related to the Game.

Administrator reserves the right, in its sole discretion to cancel or suspend this Game, or randomly award the prizes from among all eligible Entrants received or award no prizes should fraud, virus, bugs or other causes beyond the control of Administrator corrupt the administration, security or proper play of the Game.

Should multiple users of the same e-mail account enter the Game and a dispute thereafter arises regarding the identity of Entrant, the authorized subscriber of said e-mail account at the time of entry will be considered the Entrant. "Authorized account subscriber" is defined as the natural person who is assigned an email address by an Internet access provider, on-line service provider or other organization which is responsible for assignment e-mail address or the domain associated with the submitted e-mail address. Any potential winner may be requested to provide Administrator with proof that such winner is the authorized account holder of the email address associated with winning entry.

All Entrants must have a valid email address. Administrator reserves the right at its sole discretion, to disqualify any Entrants who tamper with the entry process.

The Administrator, its directors, employees or agents are not responsible for errors, problems or malfunctions relating to or in connection with the Game, including without limitation, errors, problems or malfunctions which may occur in connection with the administration of the Game, the announcement of the prizes, the processing of entries or in any Game -related materials; or for transactions that are lost, misdirected, or fail to enter into the processing system for any reason; or are processed, reported, or transmitted late or incorrectly; or are lost for any reason, including computer, telephonic, paper-transfer, or human error, or electronic, computer, or telephonic malfunction, damage, error, omission, interruption, defect, delay in operation or transmission, or any combination thereof. Any and all warranties and/or guarantees on a prize (if any) are subject to the respective manufacturers' terms therefor, and the winner(s) agrees to look solely to such manufacturer(s) for any such warranty and/or guarantee.

All trademarks are the property of their respective owners.

**9. Governing Law.**

The Game, shall be governed by, and construed in accordance with, the laws of State of Illinois, without giving effect to any choice of law or conflict of law rules. Entrants agree and consent to the jurisdiction and venue of the federal, state and local courts located in Cook County Illinois.





## **Rules Governing Individuals and Teams While On the 2019 AMA Annual Meeting Scavenger Hunt**

All individuals and teams will be expected to comply with these rules while on the scavenger Hunt. If the Game judges find that an individual or team violated any of the Game Rules, the violation shall be grounds for disqualification of the Team.

### **1. Safety First At All Times.**

Individuals or Teams must not engage in any activity or behavior that threatens the safety of themselves or others. **No running allowed inside the Hotel.**

### **3. Fair Play At All Times.**

-Any compromise to the fair and proper conduct of this Game may result in the disqualification of an Entry, termination of the Game, or other remedial action, at the sole discretion of Administrator.

-Teams can split up and work separately to complete tasks or find answers.

-The list of tasks can be completed in any order.

-Teams will be expected to find answers from published resources.

-Taking and submitting photographs during the Game is expected.

-Getting answers from non-Team members (such as family, friends, colleagues) is allowed.

-Calling a friend for help with answers is allowed.

-No cheating, stealing or sabotaging of other teams.

-Sharing or trading answers with other teams is not allowed.

-Submitting old photographs taken before the Game is not allowed.

-For team photos, photos must include all team members taken at the same place and at the same time. All team members must be readily identifiable. Altered or merged or edited photos are not allowed.

-No Entrants are expected or required to spend any money to participate in the Game.

-While playing the Game, stay within the Game Boundaries.

### **4. Courtesy At All Times.**

When interacting, individuals and teams are expected to be polite and respectful of their teammates and others.
