*Interested party requests will not be processed until the interested party submits a signed confidentiality agreement and disclosure of interest form. Interested party requests will be processed within 5 days of receipt of the requested forms. Commenters will follow the deadline instructions in the correspondence provided by AMA staff. The deadline for request to review any non-Pathology/Laboratory code change applications is **April 23, 2020**. The deadline for submission of written comments for non-Pathology/Laboratory applications is **April 30, 2020**.
