The applicant(s) who submitted the original code change application is automatically considered an interested party and are notified by AMA staff of any request for review submitted by another party.

*Interested party requests will not be processed until the interested party submits a signed confidentiality agreement and disclosure of interest form. Interested party requests will be processed within 5 days of receipt of the requested forms. Commenters will follow the deadline instructions in the correspondence provided by AMA staff. The deadline for request to review any non-Pathology/Laboratory code change applications is **September 10, 2020.** The deadline for submission of written comments for non-Pathology/Laboratory applications is **September 17, 2020**.
