REPRESENTATION IN THE AMA-YPS ASSEMBLY

RECOMMENDATION:

Recommendations in Report B be adopted and the remainder of the Report be filed.

FINAL ACTION: Recommendations in Report B be adopted and the remainder of the Report be filed.

The Governing Council recommends that the following statements be adopted and that the remainder of the report be filed.

1. YPS Governing Council will continue to work with appropriate YPS committee members to connect with current and potential members that are part of state medical societies not represented in the AMA-YPS and encourage them to serve as liaisons to the young physicians in their society or identify someone in their society for further outreach.
2. The YPS Governing Council will continue to work with appropriate YPS committee members to communicate with state societies currently represented in the AMA-YPS Assembly to highlight the work accomplished during the Assembly meetings and facilitate dialogue about increasing representation in the AMA-YPS where appropriate.
3. The YPS Governing Council will continue to reach out to state societies that are eligible for representation in the AMA-YPS Assembly that have not sent a representative in the past two years.
4. The YPS Governing Council will continue to reach out to state societies that are eligible for representation in the AMA-YPS Assembly that have sent less than the allotted number of representatives.

Limited, but supportive, testimony was received on the strategy to increase representation and promote active participation among state medical societies in the AMA Young Physicians Section (YPS) Assembly. Your Reference Committee recommends that Report B be adopted and the remainder of the report be filed.

16 members and young physician members to engage with current and potential
17 members that are part of specialty societies not represented in the AMA-YPS and
18 encourage them to serve as liaisons to the young physicians in their society or
19 identify someone in their society for further outreach.

21 2. The YPS Governing Council will continue to connect with specialty societies that
22 are eligible for representation in the AMA-YPS Assembly that have not sent a
23 representative in the past two years.

24
25 3. The YPS Governing Council will continue to reach out to specialty societies that
26 are eligible for representation in the AMA-YPS Assembly that have sent less than
27 the allotted number of representatives.

28
29 4. The YPS Governing Council will reach out to the American Society of
30 Cytopathology* to notify this specialty society of its eligibility for representation in
31 the AMA-YPS Assembly.

33 5. The YPS Governing Council will reach out to the American Academy of Sleep
34 Medicine* to notify this specialty society of its eligibility for additional representation
35 in the AMA-YPS Assembly.

37 Commentary provided during the online forum was limited, yet supportive of the plan to
38 expand specialty society representation and involvement in the AMA-YPS Assembly. Your
39 Reference Committee recommends that Report C be adopted and the remainder of the
40 report be filed.

42 (3) REPORT G: AMA-YPS DIRECTIVES PROPOSED FOR

1 **FINAL ACTION: Recommendation in Report G be adopted**
2 **and the remainder of the Report be filed.**

4 The Governing Council recommends that the AMA-YPS sunset the directive,
5 Improving Prevention and Emergency Response through Flexible Public Health
6 Funding Based on Population Risks (YPS Resolution 2-A-18).

7
8 No testimony in opposition to the report was provided. This directive originated from the
9 adoption of Resolution 2-A-18, Improving Prevention and Emergency Response through
10 Flexible Public Health Funding Based on Population Risks. Resolution 2-A-18 asked the
11 AMA to encourage federal, state, and local agencies to partake in syndromic surveillance,
12 assess risks of local populations for disease, and develop comprehensive plans with other
13 stakeholders to enact actions for mitigation, preparedness, response, and recovery in the
14 event of an unexpected infectious disease outbreak. Resolution 2-A-18 was referred for
15 study with a report back to the AMA-YPS Assembly at the 2019 Annual Assembly Meeting.
16 Report E-A-19, “Improving Prevention and Emergency Response through Flexible Public
17 Health Funding Based on Population Risks” recommended that Resolution 2-A-18 be
18 adopted as amended and submitted for consideration at the 2019 Interim Meeting of the
19 AMA House of Delegates (HOD). This resolution, considered by the AMA HOD as
20 Resolution 912-I-19, was adopted. AMA Policy H-440.892, Bolstering Public Health
21 Preparedness, was appended as a result.

22
23 The Reference Committee concurs with the Governing Council recommendation to sunset
24 the directive, Improving Prevention and Emergency Response through Flexible Public
25 Health Funding Based on Population Risks (YPS Resolution 2-A-18). Therefore, your
26 Reference Committee recommends that Report G be adopted and the remainder of the
27 report be filed.

3 (4) REPORT I: AMA BYLAWS ON YPS GOVERNING
4 COUNCIL ELIGIBILITY

5 **RECOMMENDATION A:**

6 Recommendation 1 in Report I be amended by addition and deletion to read
7 as follows:

8 The AMA-YPS Governing Council recommends introduction of YPS
9 Resolution 1 (November 2020), "AMA Bylaws Language on AMA Young
10 Physicians Section Governing Council Eligibility," which includes the
11 following Resolve clause:

12 **RESOLVED**, That the American Medical Association amend AMA Bylaw
13 7.52, Cessation of Eligibility, to allow an individual elected as YPS Chair-
14 Elect to move through the Chair and Immediate Past Chair positions even
15 if ~~he or she~~ they no longer ~~is~~ are considered a young physician under the
16 section membership eligibility criteria. (Modify Bylaws)

17 **RECOMMENDATION B:**

18 Report I be adopted as amended and the remainder of
19 the Report be filed.

26 Governing Council Eligibility," which includes the following Resolve clause:

27 **RESOLVED**, That the American Medical Association amend AMA Bylaw 7.52,
28 Cessation of Eligibility, to allow an individual elected as YPS Chair-Elect to
29 move through the Chair and Immediate Past Chair positions even if he or she
30 no longer is considered a young physician under the section membership
31 eligibility criteria. (Modify Bylaws)

32 2. The AMA-YPS Governing Council recommends that YPS Resolution 1 (November
33 2020), "AMA Bylaws Language on AMA Young Physicians Section Governing
34 Council Eligibility," be submitted for consideration at the November 2020 Special
35 Meeting of the AMA House of Delegates.

36 Online forum commentary was supportive of the recommendations in Report I. Your
37 Reference Committee proffered an amendment to the Resolve clause that replaces the

1 gender binary language with inclusive language. Therefore, your Reference Committee
2 recommends that Report I be adopted as amended.

Report A is a compilation of activities accomplished by the AMA-YPS since the 2019 Interim Meeting. The AMA-YPS budget is based upon the AMA's annual budgeting process, which must receive final approval from the AMA's Board of Trustees. Therefore, the AMA-YPS Governing Council does not directly set, control, or oversee the AMA-YPS budget. Report D is informational and does not include recommendations.

ELECTRONIC BALLOTTING PROCESS

RECOMMENDATION:

Report E be filed.

FINAL ACTION: Report E be adopted.

Report E provides the status of the AMA-YPS electronic balloting pilot. The AMA-YPS Assembly adopted Report C-I-19, Pilot AMA-YPS Electronic Balloting Process, which recommended that the election procedures outlined in the YPS Internal Operating Procedures (IOP) (Section V. Subsections E and F) be suspended in order to pilot an online balloting process during the 2020 Annual meeting. This informational report notes that this pilot will be delayed until the appropriate time to allow for proper implementation and review.

23 Report H provides an update on the pilot for an opt-in/opt-out system for printed Assembly
24 meeting materials. Resolution 3-I-19, "Opt-in/Opt-Out Paper Copies of Young Physicians
25 Section (YPS) Assembly Materials," asked the AMA-YPS Governing Council to move
26 toward an opt-in/opt-out system to determine distribution of printed Assembly materials.
27 Further, this resolution asked the YPS Governing Council to poll meeting attendees upon
28 registration for the YPS Assembly to determine if they would like a printed copy of
29 Assembly meeting materials. During the online forum, it was noted that a significant
30 number of participants had concerns or were not in favor of moving to an opt-in/opt-out
31 system for printed Assembly materials. As both printed and electronic distribution of
32 meeting materials present benefits and challenges, it was important to understand the
33 impact of an opt-in/opt-out system on the Section.
34

35 Resolution 3-I-19 was adopted as amended and called for the YPS Governing Council to
36 conduct a pilot for the 2020 Annual meeting and follow up with a report back to the YPS
37 Assembly at the 2020 Interim meeting. This informational report notes that the pilot for the
38 YPS opt-in/opt-out system for printed Assembly meeting materials will be delayed until the
39 appropriate time to allow for proper implementation and review.
