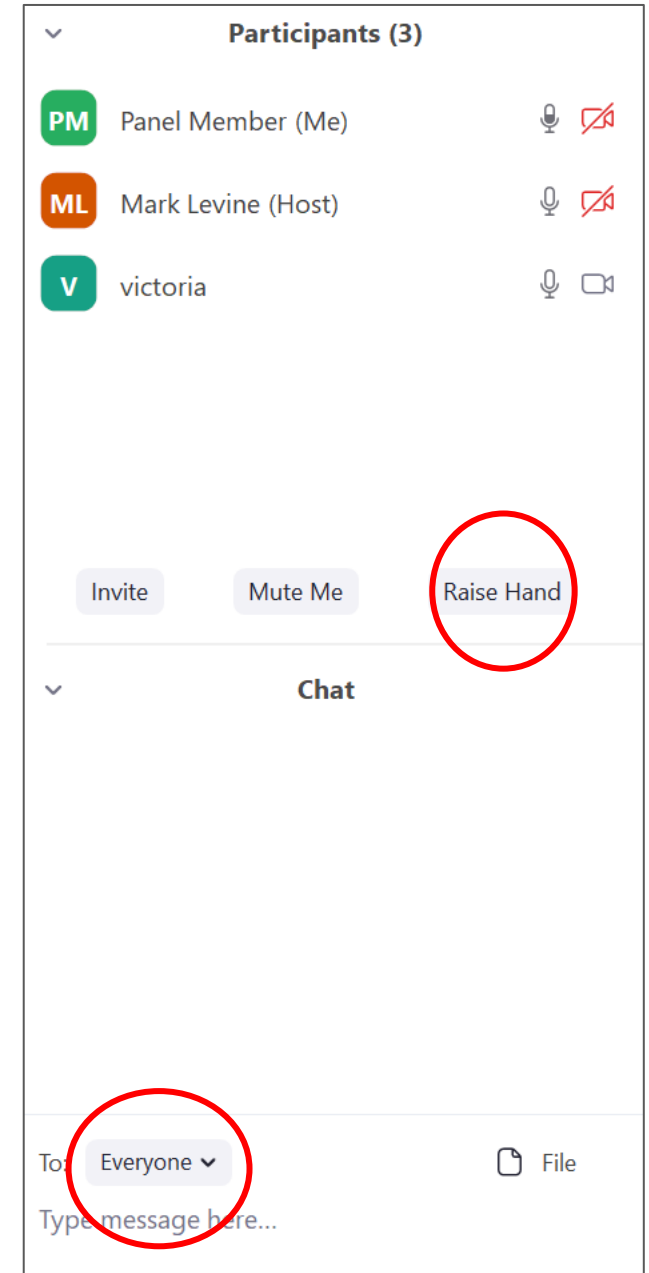
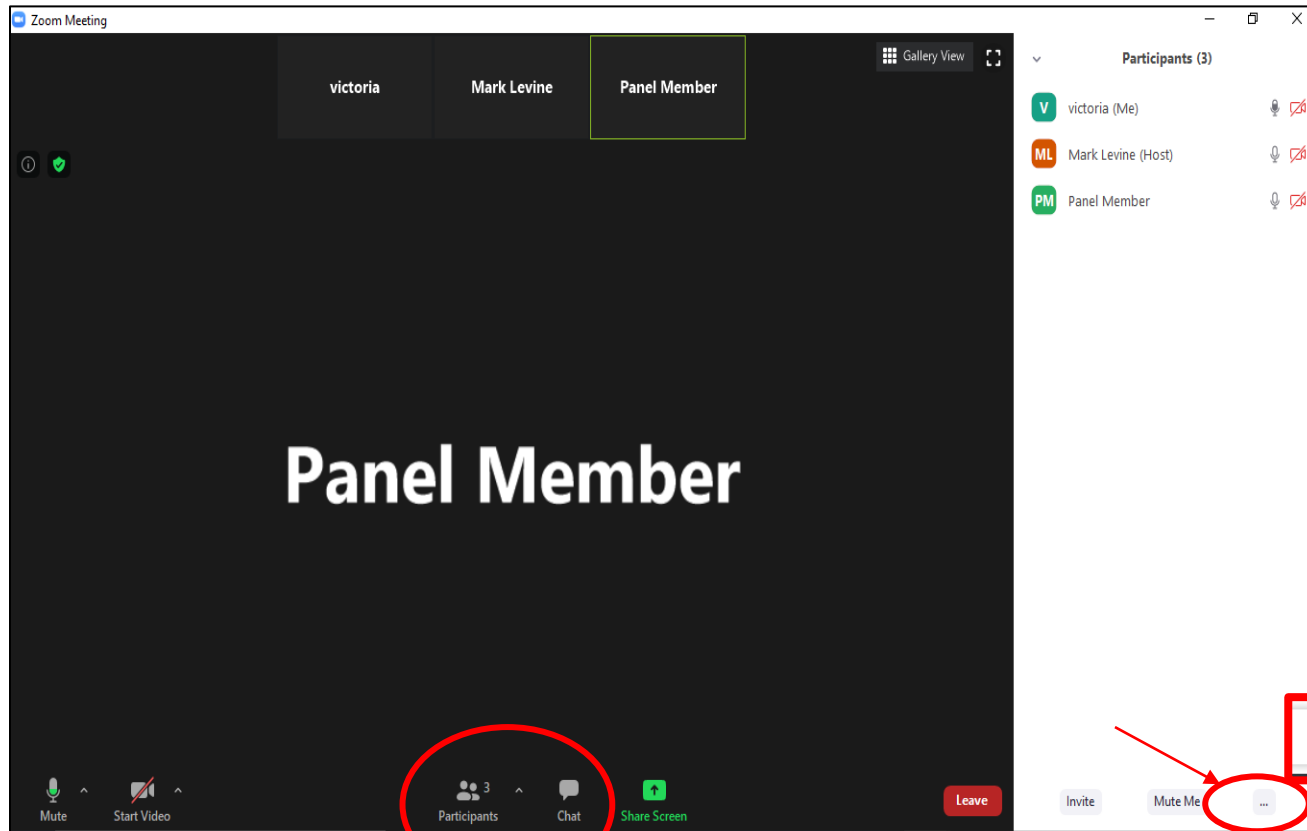

Chapter 3 & Chapter 17

- Redundancy is noted in the form of Appendix 3-1 entitled, “Pain Disability Questionnaire,” page 43 in that the exact same similar questionnaire is also found within Figure 17-A, on page 600 (interestingly within the “Appendix” section).
- The directions for the PDQ instruct that the patient is to “mark one number on each scale that best describes how you feel.” I would suggest the work “mark” be exchanged with the term, “circle” (one number), as that is more clear. I’m sure other users of this PDQ will indicate their frustration when the PDQ is “marked with a check or an “x” in between the numbers, causing the physician to further question and improve their responses.
- **Does the Panel have a desired action to take to address this?**

Chapter 5

- Rib fractures are not listed in the glossary/index. This orthopedic surgeon would appreciate some AMA clarification as to whether or not my historic use of Section 5.4c page 82 or Table 5-4 page 88 might be the appropriate section and table for such injuries.
- Thus, I believe the glossary/index deserves a section for “rib fracture” as well as that particular section or table having additional clarification, removing all doubt.
