Additional verbal comments on any issue can be provided in person at the Panel meeting following a statement of conflict of interest. The applicant(s) who submitted the original code change application is automatically considered an interested party and are notified by AMA staff of any request for review submitted by another party.

*Interested party requests will not be processed until the interested party submits a signed confidentiality agreement and disclosure of interest form. Interested party requests will be processed within 5 days of receipt of the requested forms. Commenters will follow the deadline instructions in the correspondence provided by AMA staff. The deadline for request to review any non-Pathology/Laboratory code change applications is **April 15, 2021.** The deadline for submission of written comments for non-Pathology/Laboratory applications is **April 22, 2021**.
