Left Side: Info Page/Messaging

- View information

Right Side: Meeting Window

- Raise hand to speak *after* being called on by the Chair
- Enable audio to participate in the discussion *after* being called on by the Chair

Step 3: When prompted, enable your microphone and speak.

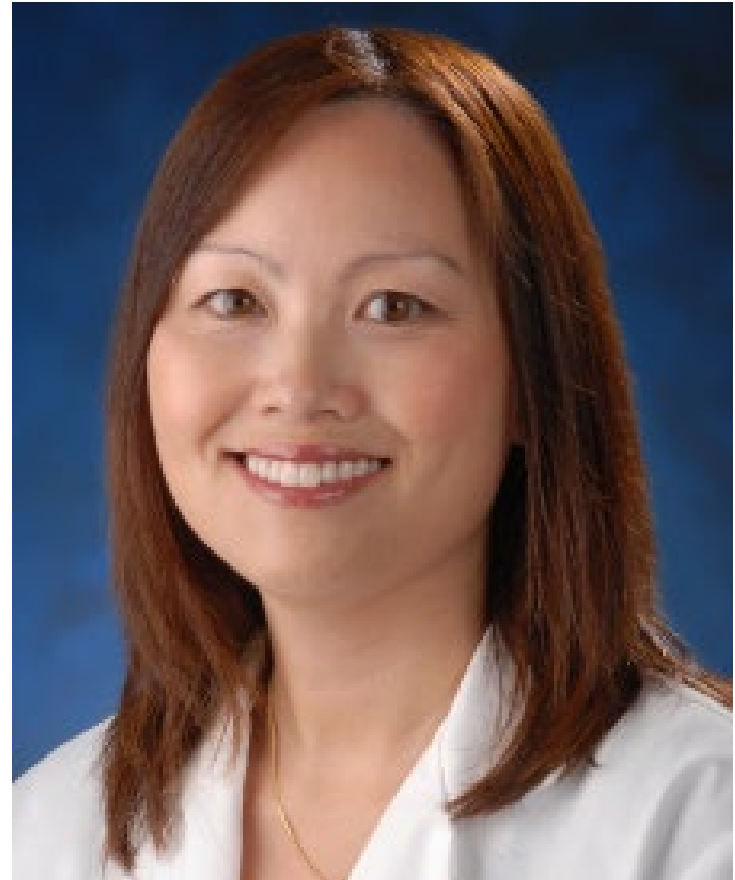
- **Program description:**
