# **House of Delegates schedule**

The 2024 Annual Meeting of the AMA House of Delegates (HOD) will be held June 7–12 at the Hyatt Regency Chicago. The AMA-HOD will convene at 6:00 pm Friday, June 7 in the Grand Ballroom, and your Speakers ask that delegates be seated by 5:50 pm We anticipate that the Opening Session will run for about two hours.

On Saturday, June 8, the "Second Opening" of the AMA-HOD will be in session beginning at 12:30 pm to receive items of business, consider acceptance of late resolutions, and extract informational reports and items from the reaffirmation consent calendar.

Reference committee hearings that meet on Saturday, June 8 will begin at 1:30 pm, or 15 minutes after the conclusion of the Second Opening and continue until completed. The schedule and locations for Reference Committee Hearings at A-24 are as follows:

Consideration of reference committee reports will begin at 1:00 pm on Monday, June 10. The Election Session will be held Tuesday, June 11 at 8 am. All voting delegates must be credentialed by 6 pm Monday evening; no substitute or temporary delegates will be credentialed after this time. Voting card distribution will begin at 7 am, and all delegates should be seated by 7:45 am. The Business Sessions will resume following the Election Session on Tuesday and on Wednesday, June 12 at 8:30 am and conclude at 12 pm. Please schedule departures for late afternoon on Wednesday so that the business debated that day can receive full consideration.

#### Handbook distribution

The HOD Handbook has been posted as both the traditional single large document and also by reference committee. There will NOT be an addendum. An abridged handbook containing only the recommendations from reports and the resolve clauses from resolutions is also available as a Word document and as a Google sheet. Primary distribution of the handbook is by download from the Annual Meeting <a href="website">website</a>. Hardcopy handbooks have been mailed only to those who have so indicated.

#### Online member forums

All on-time resolutions have been included in the Online Forum. Your Speakers encourage members to fully utilize the Forum for posting comments and engaging in robust discussion. Pursuant to Policy D-600.956, all commentary submitted to the online member forums will be used to generate a preliminary document. Reference committee **Preliminary Documents** will again include **anticipated actions** based on Online Forum testimony in order to better "inform the discussion at the in-person hearings," but the original report or

resolution will remain the topic for discussion. For example, it would be in order for the author of the resolution to present the resolution and then agree or disagree with the reference committee's suggested action in their Preliminary Document.

Policy D-600.956 further specifies that the forums should be open no longer than 14 days. The forums opened May 13 and will close May 26 at 10:00 pm CT, which will allow the reference committees to develop and post their preliminary documents on June 3. The forums can be accessed directly at <a href="mailto:ama-assn.org/forums/house-delegates">ama-assn.org/forums/house-delegates</a> or via the meeting website.

In order to more easily identify your post, please restate your name and add all of your applicable roles (e.g. Author, HOD Delegate or Alternate from X Delegation, Section Member, Council Member, etc.) and for whom you are speaking (on behalf of yourself or your group) IN ALL CAPS AT THE START OF YOUR POST within the comment box. Any posts that are not appropriately identified will be removed. Authors are encouraged to post first and all members are encouraged to post early so that others may react to your comments in a robust discussion.

The sort features within the Forum have been enhanced for A-24 with the ability to sort by topic, by number of comments, and by most recent comments. We hope this will better enable the discussion on the Forum.

# **Meeting Registration**

# Registration

All attendees of the House and Section meetings must <u>register online</u>. Registration for the House, Specialty and Services Society and all Sections meetings can be completed on this same site. You must personally register to attest for yourself and your guests to the Code of Conduct for the meeting as well as the Health and Safety Protocol.

The House of Delegates Registration Desk will be on the lower level in the Grand Foyer as usual. For security purposes, all attendees will be required to provide photo identification at the AMA Registration Desk to receive their credentials and other materials. Registration will open Thursday, June 6 (7 am) and daily (starting at 7 am) through Wednesday, June 12.

Please note that nothing may be placed on or attached to your badge except approved ribbons, as the badge will include security features that must be visible for you to enter all meeting areas.

Delegates and alternate delegates should check with their sponsoring society well ahead of their arrival in Chicago to ensure that their names have been submitted to the Office of House of Delegates Affairs. Under AMA bylaws all delegates and alternate delegates must be credentialed by the society that they will represent before each meeting. Individuals whose credentials have not been confirmed prior to the Annual Meeting will have to be accompanied to the AMA Registration Desk by an officer of their society in order to register.

HOD delegates and alternate delegates must be <u>credentialed by their sponsoring society</u>. Each delegate and alternate delegate must <u>personally register</u> through CVENT for this meeting. Please note that these are unique processes and that sponsoring societies should not attempt to register delegates and alternates via CVENT.

Your Speakers have determined that business casual dress is appropriate for the Annual Meeting, although business attire is requested for those seated on the dais during HOD business sessions. The inaugural and president's dinner reception and dance is black tie optional, business/cocktail attire is acceptable.

# **Code of conduct**

Our AMA has a robust code of conduct for AMA-sponsored meetings to ensure a professional and ethical environment for all attendees. Everyone should feel safe and able to participate without fear of unwelcome conduct. Attendees should conduct themselves in a manner that comports with the highest ideals of the profession. As a condition of attending and participating in any meeting all attendees must agree to adhere to this Code of Conduct as part of the registration process. The Code of Conduct extends beyond formal sessions to include all dinners, receptions, and social gatherings held in conjunction with AMA-hosted meetings. AMA policy and further details regarding the Code of Conduct can be found at <a href="mailto:ama-assn.org/codeofconduct">ama-assn.org/codeofconduct</a>.

Our standing rules, which are ratified in the Opening Session, commit each of us to be courteous, respectful, and collegial in the conduct of HOD business. Everyone has the personal responsibility, while engaging with others, to consider how others will interpret their actions and words.

The Office of General Counsel will appoint a "Conduct Liaison" for all AMA House of Delegates meetings and all other AMA-hosted events. The Conduct Liaison receives reports of alleged policy violations, conducts investigations, and initiates both immediate and longer-term consequences for such violations. Alternatively, violations may be brought to the attention of the presiding officer or reported using a third party reporting hotline (800-398-1496 and online). Anonymous reports may be made via the website.

# **Conflict-of-interest policy**

Immediately prior to testifying before the House or a reference committee, every individual must publicly disclose their actual or potential conflicts of interest, if any. A disclosable "conflict of interest" is an interest that is or may be material to the matter being considered and that would reasonably be expected to impair the objectivity of the individual who is testifying. Conflicts of interest, however, do not include an interest that results solely from the fact the testifying individual is a physician or medical student, in recognition that most testifying individuals have the same interest. When in doubt as to whether a conflict of interest exists or is disclosable, your Speakers recommend that individuals err on the side of caution and disclose any actual or potential conflicts to preserve the integrity of our process.

Upon disclosure of any conflicts of interest, an individual may testify without encumbrance. A delegate who thinks or knows that a testifying individual has an undisclosed actual or potential conflict of interest may ask the Speakers or the reference committee chair, as applicable, to have the testifying individual disclose their conflict. The Speakers or the chair, as applicable, have sole discretion to decide all matters related to the appropriate disclosure and management of conflicts of interests before the House or reference committee, respectively. The Speakers and reference committee chairs may consult the Office of General Counsel and appropriate others as needed to decide the matter.

This guidance also applies to resolutions introduced by delegations. The sponsoring delegation must disclose the identity of any delegate or alternate delegate who has a conflict of interest with respect to matters addressed in the resolution. If a conflict is disclosed, the notation on the resolution will not contain an individual delegate's name, but will state in substance that, "In accordance with House policy regarding disclosure of conflicts of interest, the delegation has notified the Speaker that one or more delegates has a conflict of interest with respect to the matters addressed in this resolution." For resolutions already submitted, please notify the AMA Office of House of Delegates Affairs.

#### **HOD Reference Manual**

The <u>House of Delegates Reference Manual: Procedures, Policies and Practices</u> provides comprehensive information about the AMA's policy development process. It serves as the AMA-HOD Standing Rules and delineates the procedures used at our meetings. It may be especially helpful to new delegates, but it is a good reference for all meeting participants. The manual is referenced as our Standing Rules at each meeting in the report of the Rules and Credentials Committee along with any temporary rules listed on the report. # Mentorship and financial support

Medical students and residents/fellows are an integral part of our AMA and their voices are critical to our deliberative process. The integration of students and residents into the formalized state and specialty delegations provides valuable mentorship to and continued participation from these important members of our House. Our HOD has a historical commitment to supporting our student and resident/fellow delegates and alternate delegates. Delegations are encouraged to continue the financial support and active involvement of these members in their caucuses.

# Live streaming for A-24

All business sessions and reference committee hearings at the 2024 Annual Meeting will be streamed live. Links will be posted on the meeting website and appear on the Speaker's Page closer to the meeting date.

#### **Recording of AMA-HOD meetings**

Proceedings of AMA meetings may be recorded by audiotape, videotape or otherwise, for use by the AMA. Participation in/attendance at a meeting shall be deemed to confirm the participant's consent to recording and to the AMA's use of such recording.

#### **Media Presence**

It is important that all Delegates be aware that members of the media attend AMA meetings and that discussions in Reference Committee and on the HOD floor would be considered on the record. While AMA Enterprise Communications works to ensure only credentialed members of the media attend AMA meetings, Delegates should be aware that uncredentialed persons associated with non-traditional media, unscientific, or political entities may attempt to attend events during and adjacent to AMA meetings. When discussing issues/policy, the AMA, or the meeting, we encourage you to be cognizant of whom you're speaking to, what you're saying, and your surroundings as smart phones give virtually everyone the ability to record conversations. # **Candidates and Elections**

#### 2024 candidates, nominations, and elections

The 2024 HOD Annual Meeting Election Manual | AMA is currently available online. It includes statements from announced candidates for June's elections as well as a link to the conflict-of-interest disclosures that are required by House policy. The election manual is freely accessible, but conflict-of-interest disclosures are available only to members, who must login to view them.

Candidate Web Pages, for those candidates who chose to produce one, and the Speaker Interviews of candidates in currently contested races are available on the <u>Elections Page</u>. All delegates are encouraged to avail themselves of these and other opportunities to familiarize themselves with the candidates.

<u>Rules for AMA Elections</u>: The rules for AMA elections are published in the Election Manual and can be found at this link: <u>HOD election rules | American Medical Association</u>. All candidates have agreed to abide by these rules.

<u>Campaign violations:</u> Complaints should be directed to the <u>Speaker</u>, the <u>Vice Speaker</u>, or the <u>AMA General</u> Counsel and should include the following details:

- The name of the person(s) thought to have violated the rules
- The date of the alleged violation and the location if relevant
- The specific violation being alleged (i.e., the way the rules were violated)
- The materials, if any, that violate the rules; original materials are preferred over copies. Where necessary, arrangements for collection of these materials will be made.

<u>Candidate Interviews:</u> The HOD Office has developed the official list of contact information for groups that wish to interview candidates and candidates' contact information. Note that only groups that have submitted information to the HOD Office may interview candidates. The deadline to schedule **virtual** interviews has passed, but groups wishing to conduct **in-person** interviews June 7-10 are reminded of the **May 22 deadline** to submit the <u>interviewing group form</u> and identify which contests for which they wish to interview. It is the responsibility of the candidates to contact the groups' designated person to arrange an interview.

Candidates may not schedule interviews with groups that are not on the official list, and groups may not ask candidates to interview if the group did not submit its information to be included on the official list by the May 22 deadline.

<u>Nominations</u>: Nominations for all offices will be accepted during the Opening Session on Friday evening, June 7. Anyone seeking election during the Annual Meeting must be nominated on Friday evening. Once nominations are closed there will be no further opportunity for nominations even if an election results in a newly opened seat. Any delegate—not an alternate delegate unless temporarily credentialed as a delegate—may make a nomination. Only the name of the nominee and the office to be sought should be stated. With the exception of nominations for president-elect, nominating speeches or a listing of the nominee's qualifications will be ruled out of order. Officer candidates in contested elections will be allowed to address the House during the Opening Session.

House policy requires that all candidates complete a conflict-of-interest form prior to election. Individuals who anticipate the possibility of being nominated during the Opening Session should contact Jeanne Uehling in the Speakers' Office (jeanne.uehling@ama-assn.org, or phone 312.464.4344) to complete this form for posting prior to the election. Forms will be maintained in confidence until the announcement of candidacy.

<u>AMA Candidates Reception</u>: Our AMA will sponsor a reception for candidates from **5:00 to 7:00 pm Sunday evening, June 9**. The reception is open to all candidates, although not all have chosen to participate. Some candidates will be featured at other receptions. Candidates may be featured at only one reception. The AMA-sponsored reception is subject to the same rules as any other campaign reception. Instructions have been sent to all candidates. Everyone is invited to attend.

Elections at A-24: Elections will take place on Tuesday, June 11 during the Election Session in the Grand Ballroom. Election session check-in will begin at 7:00 am and all delegates should be seated by 7:45 am. For this session, extra security will be employed, and only credentialed delegates will be allowed in the delegate seating area. A limited number of guests with an Election Session pass will be admitted to be seated outside of the delegate seating area. The elections will be conducted using the handheld voting devices along with a special voting card that must be inserted to cast a valid vote. Voting will proceed sequentially starting with election of officers followed by the council races in alphabetical order. Once voting for an office, including any run-offs, has concluded, balloting for the next office will proceed until all contests have been decided.

Only duly credentialed delegates are permitted to cast a ballot. If a delegate will be unable to participate in the Election Session, an alternate delegate must be properly re-credentialed as a delegate at the AMA Registration Desk by **6 pm Monday**, **June 10**. The change from alternate delegate to delegate must be approved by a duly authorized officer of the society in question; see <u>bylaws 2.10.4 and 2.10.4.1</u>.

The following races will be determined, unless previously elected by acclamation:

- President-elect vote for one, currently one candidate
- Speaker vote for one, currently one candidate
- Vice Speaker vote for one, currently one candidate
- Board of Trustees vote for four, currently seven candidates; potential for one additional opening
- Council on Constitution & Bylaws vote for one; currently two candidates
- Council on Medical Education vote for one, currently one candidate
- Council on Medical Service vote for three, currently four candidates
- Council on Science & Public Health vote for one, currently two candidates
- Council on Science & Public Health, Resident Physician vote for one, currently one candidate

<u>CEJA nomination and election</u>: President-elect Bruce A. Scott, MD will nominate a member for a full term on the Council on Ethical and Judicial Affairs as well as a resident member during the Opening Session. The nominees' conflict-of-interest disclosure will be posted on the website in the member-only area.

# Inauguration of Bruce A. Scott, MD

The inaugural ceremony to install Bruce A. Scott, MD, as the 179th AMA president will take place at 5:00 pm on Tuesday, June 11 in the Crystal Ballroom, followed by a reception and dinner/dance in the Grand Hall and Grand Ballroom at 6:15 pm

The open-bar cocktail hour will include a bourbon tasting with bourbons personally selected by Dr. Scott. The format for this year's dinner event will be a plated dinner with reserved seating, followed by dancing from 8:00 pm-10:00 pm, featuring live music provided by the Bluewater Kings. Individual tickets can be purchased for \$130.00 per adult and \$60.00 per child (12 and under). A children's corner will be available to children accompanied by a parent or designated adult and will feature age-appropriate activities and snacks.

Announcements should be formatted for 16:9 projection in the House. Announcements received before noon, Monday, June 10 will be projected on the last day of the meeting. Submissions will be maintained in confidence until projected. Announcements will be posted online on the candidate page after the meeting.

# \*Envisioning Medical Education's Equitable Future Monday, June 10, 8:00 - 9:00 AM, Grand Hall G/H Program hosted by AMA Medical Education

What does an equitable medical education system look like? In 2021, the HOD called for the AMA to commission a forward-looking, cross-continuum, external study of 21st century medical education focused on reimagining health equity and racial justice in medical education, improving the diversity of the health workforce and ameliorating inequitable outcomes among minoritized and marginalized patient populations. Elsevier is publishing this study in October 2024, and this education session will explore how the AMA gathered a nine-member external independent editorial panel to select the more than 70 authors who comprise the teams that wrote this study's 17 chapters. These authors were selected from the hundreds of physicians, medical students, other health professionals, and community members who submitted abstracts. This session will include how authors were selected and then empowered to communicate their ideas as they saw fit and how the AMA will fund and enact some of this study's recommendations.

# \*Equity in Healthcare: Breaking Barriers for Patients with Disabilities through Physician Advocacy Monday, June 10, 8:00 - 9:00 AM, Grand Hall I Program hosted by the Mobility Caucus

CME credit is offered through the University of Kansas

This educational session aims to empower physicians from all specialties to help bridge the gaps in healthcare for patients with disabilities and to provide information that participants can bring back to their practices. Recognizing the unique challenges facing patients with disabilities, the session will not only highlight personal patient narratives and the barriers they have faced but also provide participants with the information needed for physicians to advocate for the highest quality of care.

The session will discuss insurance barriers, such as rehabilitative therapy caps and the progress made in reducing such caps to improve patient care, as well as review the services and equipment that are now covered by insurance, and the current advancements in federal legislation to expand access to medical rehabilitation services and coverage of orthotics, prosthetics, and assistive devices. The session will emphasize the need for ongoing, transparent disability-related dialogues across specialties and with policymakers and how to best engage in these conversations. Physicians will leave the session with a better understanding of the importance of rehabilitation and how to best advocate for their patients with disabilities on a national, local, and organizational level.

# \*Training Physicians in the Art of the Public Forum Monday, June 10, 8:15-9:45 AM, Grand Hall J Program hosted by AMA Enterprise Communications

Training Physicians in the Art of the Public Forum, hosted by AMA Enterprise Communications at Annual 2024, will provide physicians with tools and techniques to effectively dispel medical misinformation and engage the public on important issues. This session will help physicians from all backgrounds and specialties become better advocates—for themselves and their patients, push back on the rampant spread of medical misinformation; and prepare for public speaking opportunities and interviews with local media.

# Reducing Maternal Morbidity and Mortality - Working Together as a House of Medicine Monday, June 10, 8:30 - 10:00 AM, Grand Hall K

# Program hosted by American College of Obstetricians and Gynecologists

Maternal morbidity and mortality rates remain high in the United States. More than 80 percent of maternal deaths are preventable, and the top three causes are mental health, anemia, and cardiac disease/hypertension Reducing maternal morbidity and mortality will require expertise and collaboration across specialties. Attendees will learn about evidence-based recommendations to improve maternal health, the latest policy conversations, and opportunities to reduce disparities in maternal morbidity and mortality.

# \*Exploring the Impacts of Current Political Debates on Medical Education Monday, June 10, 9:15 - 10:15 AM, Grand Hall G/H Program hosted by the AMA Council on Medical Education

AMA policies such as AMA Stance on the Interference of the Government in the Practice of Medicine H-270.959, Government Interference in Patient Counseling H-373.995, and Freedom of Communication Between Physicians and Patients H-5.989 emphasize the AMA's position on protecting the physician-patient relationship from political interference. However, the domain of medical education nonetheless experiences downstream effects from a variety of political debates within the United States, even in the absence of specific federal or state policies. Medical educators must navigate complex and sensitive issues, such as gun safety, reproductive health care, and gender-affirming care, in the effort to provide adequate training to medical education learners across the continuum.

This AMA Council on Medical Education A-24 educational session, presented by expert speakers in the medical education domain, will highlight concerns regarding how wider political debates can create complications in the training of future and current physicians, and will offer strategies and insights to promote effective medical education in the face of these challenges.

# Litigation Center Open Meeting Monday, June 10, 9:30 – 11:30 AM, Regency A Program hosted by the AMA Litigation Center

The presentations will concern litigation efforts (a) to compel the Food and Drug Administration to ban the manufacture of menthol-flavored cigarettes, (b) to challenge a West Virginia regulation that would permit optometrists to perform surgery on eyelids, and (c) to support state laws that protect physicians from malpractice liability on account of their care for patients during the COVID-19 crisis.

# \*Health Care Strategies for Firearm Injury Prevention Monday, June 10, 10:00 – 11:30 AM, Grand Hall J Program hosted by AMA's Firearm Injury Prevention Task Force

Injuries and deaths from firearms are a public health crisis. In 2020, firearm injuries became the leading cause of death in children and adolescents in the United States. While this is a topic that physicians should openly discuss with patients, physicians may find counseling patients about firearm injury prevention difficult. Furthermore, options for intervening when patients are found to be at risk of self-harm or harm to others may vary by state. In this session, we will explore the epidemiology of firearm morbidity and mortality, discuss factors that increase the potential for firearm injury and death, and learn about evidence-based interventions. Attendees will hear directly from physicians and health systems that are a part of the AMA's Firearm Injury Prevention Task Force that are working to normalize conversations about firearm safety and build comprehensive models of care that address the intersectional nature of trauma, social determinants of health and violence.

# Physicians' Role in Fetal Alcohol Syndrome Prevention Monday, June 10, 10:15 – 11:45 AM, Grand Hall K Program hosted by FASD

This session will focus on how addiction can impact a woman's health, family, children, and their unborn babies. Research on lifelong cognitive, neurological, and behavioral disorders related to prenatal alcohol exposure will be reviewed. Additionally, research on stigma towards mothers of children that used during their pregnancy will be summarized. Women with this lived experience face on-going stigma and bias, loss of their children, and debilitating shame that can place them at high risk for relapse. The focus of the session will be on how education on both addiction and recovery transforms systems of care to reframe both expectations and interventions to improve outcomes for women and their families. Participants will learn about resources for women and their families.

# \*Marginalized Perspectives on Restorative Justice in Medicine Monday, June 10, 10:30 AM – 12:00 PM, Grand Hall I Program hosted by AMA Center for Health Equity

The session will begin with an overview of the Canadian Medical Association's (CMA) truth and reconciliation initiative followed by perspectives from minoritized physician group leaders on how lessons learned from the experiences of Canadian physicians might be applied in the US.
