Objective: Increase number of resolutions that align with MAS strategic priorities.

Tactics:

- Increased communications from staff and MAS Delegate to section and GC members regarding timeline and deadlines for A-24 draft resolutions and suggested topics via section newsletter, GroupMe account, and emails from staff.
- Policy-making orientation session delivered by the MAS Delegate to Governing Council (GC)
 members regarding protocols for resolutions (e.g., how to submit ideas; collaboration on topics;
 overview of deliberations within Reference Committees and the full House of Delegates; defining
 policy impact)
- Direct solicitation by section chair and staff encouraging GC members to leverage their expertise and professional concerns in the development of impactful resolutions.
- Shared templates, sample resolutions and other resources with members.
- Promoting an online submission form for resolution ideas.

Top priority policy topics for A-24:

MAS is considering sponsoring or co-sponsoring resolutions on the following topics:

- Medical education for members in underserved minority populations
- Improving healthcare of Hispanic populations
- AMA's support for STEMM-focused pathway programs
- Improving healthcare, representation in the house of medicine, increasing access to training opportunities, and the reduction of cancer disparities among American Indian / Alaska Native and other rural minority populations.
- Establishment of an AMA-led diversity mentorship program
- Voter rights
- Public health and medicine among immigrants, migrants, and refugees

MAS leaders will confer after the April 1 resolution submission deadline to review drafts and determine next steps.

Education topics for A-24:

"Indigenous Peoples And Gender Diversity: An Intersectional Approach To Health Equity" is a non-CME education program that will feature a physician and their partner – both of whom identify as "Two-Spirit" individuals and co-sponsored by MAS, MSS, and LGBTQ.
