Our AMA has strongly advocated for maintained access to vaccines and has opposed all recent Administration actions with respect to the removal and replacement of ACIP members. In June, AMA advocated for a Senate inquiry into the circumstances surrounding the removal of all existing ACIP members, as well as sending a letter to HHS strongly opposing the removal and replacement of existing ACIP members. The AMA has continued to oppose any and all actions taken to limit access to vaccines.
