CPT® Editorial Summary of Panel Actions April-May 2023

Please be aware that this action is a reflection of the discussion at the most recent virtual Panel meeting.

The SARS-CoV-2 Vaccine product CPT code and immunization CPT codes can be found on the AMA Website.

Revision of 7 Category I codes (0124A, 0134A, 0144A, 0154A, 0164A, 0173A, 0174A) and addition of 6 Category I codes (0121A, 0141A, 0142A, 0151A, 0171A, 0172A) accepted by the CPT Editorial Panel. New codes 0121A, 0141A, 0142A, 0151A, 0171A, 0172A, and revised codes 0124A, 0134A, 0144A, 0154A, 0164A, 0173A, 0174A, and all related references will be published in CPT 2024. Guidelines and parenthetical notes are only effective for codes that have received FDA Emergency Use Authorization (EUA) approval.

Replace the term "booster" with "additional dose" for bivalent Pfizer and Moderna administration codes (0124A, 0134A, 0154A, 0164A, 0174A,) in the Appendix Q table.

Updated administration guidance for monovalent Pfizer and Moderna vaccine codes (91300, 91301, 91305, 91306, 91307, 91308, 91309, 91311) in the Appendix Q table.

Revise patient age for vaccine code 91314 in the Appendix Q table.

As of April 18, 2023, the monovalent Moderna and Pfizer-BioNTech COVID-19 vaccines (0001A, 0002A, 0003A, 0004A, 0011A, 0012A, 0013A, 0051A, 0052A, 0053A, 0054A, 0064A, 0071A, 0072A, 0073A, 0074A, 0081A, 0082A, 0083A, 0091A, 0092A, 0093A, 0094A, 0111A, 0112A, 0113A 91300, 91301, 91305, 91306, 91307, 91308, 91309, 91311) are no longer authorized for use in the United States.
