

## CPT® Category I New SARS-CoV-2 Vaccine Codes Medium Descriptors

### Most recent changes to the CPT® Category I New SARS-CoV-2 Vaccine Codes Medium Descriptor document:

- As of June 1, 2023 the Janssen COVID-19 vaccine (0031A, 0034A, 91303) is no longer authorized for use in the United States.

It is important to note that further CPT Editorial Panel or Executive Committee actions may affect these codes and/or descriptors. For this reason, code numbers and/or descriptor language in the CPT code set may differ at the time of publication. In addition, further Panel actions may result in gaps in code number sequencing.

The following codes were accepted by the CPT Editorial Panel. Codes 0001A, 0002A, and 91300 are effective December 11, 2020. Codes 0011A, 0012A, and 91301 are effective December 18, 2020. Codes 0031A and 91303 are effective February 27, 2021. Revised code 0031A is effective October 20, 2021. Codes 0003A and 0013A are effective August 12, 2021. Code 0004A is effective on September 22, 2021. Codes 0034A, 0064A, and 91306 are effective October 20, 2021. Codes 0051A, 0052A, 0053A, 0054A, 0071A, 0072A, 91305, and 91307 are effective October 29, 2021. Code 0073A is effective January 3, 2022. Codes 0094A and 91309 are effective March 29, 2022. Code 0074A is effective May 17, 2022. Codes 0081A, 0082A, 0083A, 0091A, 0092A, 0093A, 0111A, 0112A, 0113A, 91308, and 91311 are effective June 17, 2022. Revised code 0094A is effective July 6, 2022. Codes 0041A, 0042A, and 91304 are effective July 13, 2022. Codes 0124A and 91312 are effective August 31, 2022. Codes 0134A and 91313 are effective August 31, 2022 for patient aged 18 years and older. Codes 0134A (12 years through 17 years), 0144A, 0154A, 91313 (12 years through 17 years), 91314, and 91315 are effective October 12, 2022. Code 0044A is effective October 19, 2022. Codes 0164A, 0173A, 91316, and 91317 are effective December 8, 2022. Revised code 0173A and new code 0174A are effective March 14, 2023. Revised codes 0124A, 0134A, 0144A, 0154A, 0164A, 0173A, 0174A and new codes 0121A, 0141A, 0142A, 0151A, 0171A, 0172A are effective April 18, 2023.

Codes 0001A, 0002A, 0003A, 0004A, 0011A, 0012A, 0013A, 0051A, 0052A, 0053A, 0054A, 0064A, 0071A, 0072A, 0073A, 0074A, 0081A, 0082A, 0083A, 0091A, 0092A, 0093A, 0094A, 0111A, 0112A, 0113A, 91300, 91301, 91305, 91306, 91307, 91308, 91309, and 91311 are no longer authorized for use in the United States as of April 18, 2023.

**Codes 0031A, 0034A, and 91303 are no longer authorized for use in the United States as of June 1, 2023.**

Codes 0021A, 0022A, 0104A, 91302, and 91310 will be effective upon receiving Emergency Use Authorization or approval from the Food and Drug Administration.
