## CPT® Editorial Summary of Panel Actions May 2022

Please be aware that this action is a reflection of the discussion at the most recent telephonic Panel meeting.

The SARS-CoV-2 Vaccine product CPT code and immunization CPT codes can be found on the [AMA Website](#).

Addition of 3 Category 1 codes (0111A, 0112A, and 91311) accepted by the CPT Editorial Panel. Codes 0111A, 0112A, 91311 and all related references will be published in CPT 2023. Guidelines and parenthetical notes are only effective for codes that have received FDA Emergency Use Authorization (EUA) approval.

Add the term “patient age” to the guidelines in the Medicine and Appendix Q sections.

Update code range to 91300-91311 by replacing 91310 with 91311 throughout the code set.
