Interested party requests will be processed within 5 days of receipt of the requested forms. Commenters will follow the deadline instructions in the correspondence provided by AMA staff. The deadline for request to review any non-Pathology/Laboratory code change applications is **January 13, 2022**. The deadline for submission of written comments for non-Pathology/Laboratory applications is **January 20, 2022**.
