View an account activity page of detailed transactions, payment details and purchaser information to keep track of your finances.

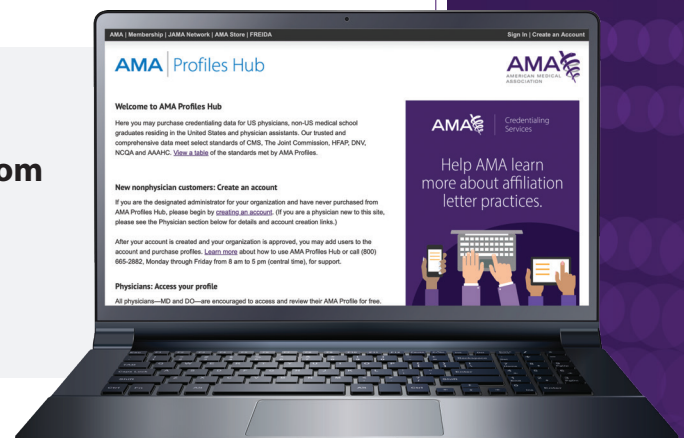

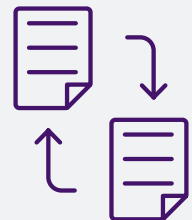
