Subject: 2026 Constituent Society Delegate Apportionment

I am pleased to provide delegate apportionment figures for 2026. Under American Medical Association (AMA) Bylaws (§2.1 and subsections), states and territories (referred to as constituent associations) in the House of Delegates will be apportioned a total of 350 delegates, which is an increase of 29 delegates over 2025.

Delegate apportionment is based on official AMA membership records as of December 31, 2025, with one delegate apportioned for every 1,000 AMA members, or fraction thereof. The constituent association delegate apportionment table attached provides a state-by-state breakdown.

Those states that have endorsed regional medical student delegates or resident sectional delegates should be aware that these delegates are not reflected in the figures that appear in the constituent society apportionment table, but rather appear in separate tables, also attached. Regional medical student delegates and resident sectional delegates will be seated with their endorsing societies. **Student and resident alternate delegates substituting temporarily as a delegate will be seated in the space designated for the student or resident delegate endorsed by your society even though they are likely to have been endorsed by another society; please be sure your delegation is aware of this situation.** States are encouraged to include the students and resident delegates they have endorsed in delegation activities and communications.

The credentialing process for June's House of Delegates meeting will begin in early March. Under AMA bylaws, delegates and alternate delegates must be certified before *each* meeting. You will receive a separate communication regarding credentials.

Please ensure that your delegates and alternate delegates have renewed their AMA memberships for 2026. AMA bylaws specify that all delegates (§2.0.1.1) and alternate delegates (§2.8.1) must be AMA members, and individuals who are not members will not be included on a delegation roster. You will be notified of any discrepancies.

Pursuant to American Medical Association Bylaws (§2.3 and subsections), medical student regional delegates and alternate delegates were elected utilizing a regional structure. The seven medical student regions are:

- Region 1: Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, Nevada, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington, Wyoming.
- Region 2: Illinois, Iowa, Minnesota, Missouri, Nebraska, Wisconsin
- Region 3: Arkansas, Kansas, Louisiana, Mississippi, Oklahoma, Texas.
- Region 4: Alabama, Florida, Georgia, North Carolina, Puerto Rico, South Carolina, Tennessee.
- Region 5: Indiana, Kentucky, Michigan, Ohio, West Virginia.
- Region 6: Delaware, District of Columbia, Maryland, New Jersey, Pennsylvania, Virginia.
- Region 7: Connecticut, Maine, Massachusetts, New Hampshire, New York, Rhode Island, Vermont.

For 2026, 26 regional student delegates (and like number of alternate delegates) were apportioned according to year-end 2024 AMA medical student membership figures within a region, with a delegate being apportioned for every 2,000 student members in the region and additional delegates apportioned per Bylaw 2.3.2.

Medical Student Section regional delegates are “seated with the constituent association representing the jurisdiction within which such delegate’s educational program is located” (Bylaw 2.10.8). Alternate delegates substituting for a delegate shall be seated in the place of the delegate being temporarily replaced.

Subject: 2026 Specialty Society Delegate Apportionment

I am pleased to provide delegate apportionment figures for 2026. The apportionment is based on official American Medical Association (AMA) membership records and Policy G-600.027, “Designation of Specialty Societies for Representation in the House of Delegates.” Constituent associations have been apportioned 350 delegates for 2026 (not including one delegate slot for the Speaker per AMA Bylaw, §2.5). Consequently, 350 delegates were apportioned across the national medical specialty societies in the House of Delegates. Adjustments to the number of delegates have been made for a number of societies so that parity is maintained with constituent associations as called for in the bylaws.

Every society seated in the House of Delegates is entitled to one delegate, but the following 77 national specialty societies have more than one delegate (with a like number of alternate delegates):

Remaining national medical specialty societies are each apportioned one delegate (and one alternate) for 2026. The net result is that there will be 350 specialty society delegates this year. Delegate apportionment figures for all specialty societies appear in the 2026 Specialty Society Delegate Apportionment table accompanying this memo. Included are the three societies expected to be seated in the House in June.

Several specialty societies have endorsed resident and fellow sectional representatives (§2.4 of the bylaws) and are listed in a second table below. The delegate numbers above and in the Specialty Society Delegate Apportionment table do not include these resident and fellow sectional delegates, but allowance will be made to seat them with their endorsing societies when meetings take place in person. You should note, however, that resident sectional alternate delegates substituting temporarily will be seated in the space designated for the resident endorsed by your society even though the alternate delegate is likely to have been endorsed by another society; please be sure your delegation is aware of this situation. Societies are encouraged to include the residents they have endorsed in delegation activities and communications.

Traditionally, delegates for national medical specialty societies with a single delegate have been seated in the House with the delegate's home state. Over the last few years, several specialty societies have indicated that they would like to be seated together, and these groupings will continue. **Other specialty society delegations that would like to be seated together in the House should notify Jeanne Uehling in writing no later than March 13, 2026.**

The credentialing process for the June meeting will begin in early March. Under AMA bylaws, delegates and alternate delegates must be certified before *each* meeting. Please ensure that your delegates and alternate delegates have renewed their AMA memberships for 2026. AMA bylaws specify that all delegates (§2.0.1.1) and alternate delegates (§2.8.1) must be AMA members, and individuals who are not members will not be included on a delegation roster. You will be notified of any discrepancies.

Subject: 2026 Delegate Apportionment

Under our American Medical Association (AMA) bylaws (§2.6), the federal services (Air Force, Army, Navy, Public Health Service and the VA), American Medical Women's Association, American Osteopathic Association, National Medical Association, and professional interest medical associations are each allotted one delegate (and one alternate) as are AMA sections.

Please ensure that your delegates and alternate delegates have renewed their AMA memberships for 2026. AMA bylaws specify that all delegates (§2.0.1.1) and alternate delegates (§2.8.1) must be AMA members, and individuals who are not members will not be included on a delegation roster. You will be notified of any discrepancies.

Organizations who have endorsed resident and fellow sectional representatives (§2.4 of the bylaws) are listed in the table below. Allowance will be made to seat them with their endorsing societies when meetings take place in person. You should note, however, that resident sectional alternate delegates substituting temporarily will be seated in the space designated for the resident endorsed by your organization even though the alternate delegate is likely to have been endorsed by another society; please be sure your delegation is aware of this situation. Organizations are encouraged to include the residents they have endorsed in delegation activities and communications.

The credentialing process for the June meeting will begin in early March. Under AMA bylaws, delegates and alternate delegates must be certified before *each* meeting.
