

#### YOUNG PHYSICIANS SECTION 2022 INTERIM MEETING - DISPOSITION OF ITEMS WITH ACTIVE POSITIONS

The YPS was an active and integral part of the House of Delegates (HOD) meeting. As directed by the YPS Assembly, the section testified on 34 items of business that were considered by the AMA HOD. 	YPS Report C-I-19, Pilot AMA-YPS Electronic Balloting Process, was written in response to concerns that other commitments precluded various YPS Assembly members from participating in-person balloting. YPS Report C-I-19 recommended that the election procedures outlined in the YPS Internal Operating Procedures (Section V. Subsections E and F) be suspended in order to pilot an online balloting process during the 2020 Annual meeting. An informational report, YPS Report E-I-20, Update on Pilot YPS Electronic Balloting Process, provided an overview of the rationale and process for implementing electronic balloting.
	YPS Report D-I-22 includes the following recommendations:
	That the AMA-YPS continue with electronic balloting for AMA-YPS elections, with an allowance for paper balloting when necessary.
	2. That the Section V. Elections (Subsections E and F) of the AMA-YPS Internal Operating Procedures be updated to provide guidelines for electronic balloting in AMA-YPS elections.
	3. That the Section V. Elections (Subsection G) of the AMA-YPS Internal Operating Procedures be updated to reflect the role of the Credentials Committee in the balloting process for AMA-YPS elections.

4. That the Section VI. YPS Assembly Meeting (Subsection K) of the AMA-YPS Internal Operating Procedures be updated to reflect the process for electronic ballot distribution during the AMA-YPS Assembly meetings.

Report E: Update on Opt-in/Opt-Out Paper Copies of Young Physicians Section (YPS) Assembly Materials (Resolution 3-I-19)

### Adopted

The purpose of YPS Report E is to provide an overview of related activity since November 2020 and propose next steps for handling paper materials at future YPS Assembly meetings.

Resolution 3-I-19, "Opt-in/Opt-Out Paper Copies of Young Physicians Section (YPS) Assembly Materials," asked the AMA-YPS Governing Council to move toward an opt-in/opt-out system to determine distribution of printed Assembly materials. Further, this resolution asked the YPS Governing Council to poll meeting attendees upon registration for the YPS Assembly to determine if they would like a printed copy of Assembly meeting materials. During the online forum, it was noted that a significant number of participants had concerns or were not in favor of moving to an opt-in/opt-out system for printed Assembly materials. As both printed and electronic distribution of meeting materials present benefits and challenges, it was important to understand the impact of an opt-in/opt-out system on the section. Accordingly, YPS Resolution 3-I-19 was adopted as amended and called for the YPS GC to conduct a pilot for the 2020 Annual meeting and follow up with a report back to the YPS Assembly at the 2020 Interim meeting. An informational report, YPS Report H-I-20, Opt-in/Opt-Out Paper Copies of Young Physicians Section (YPS) Assembly, provided an update on the status of optin/opt-out pilot.

YPS Report E-I-22 includes the following recommendations:

- 1. That the AMA-YPS continue with electronic distribution of AMA-YPS Assembly meeting materials.
- That the Sections VI. YPS Assembly Meeting (Subsections G and L) of the AMA-YPS Internal Operating Procedures be updated to reflect the use of electronic distribution for AMA-YPS meeting materials.

RESOLVED, That our AMA work with other <u>stakeholders</u> interested organizations to advocate for the United States Preventive Services Taskforce to encourage discussion of family-building plans and preconception <u>pre-pregnancy</u> family planning counseling with all <u>interested</u> individuals with reproductive potential-starting at age 30, as part of routine health maintenance (<u>Directive to Take Action</u>) (Establish New HOD Policy).

#### RECOMMENDATION B:

Resolution 1 be <u>adopted as amended</u> with a change in title to read as follows:

ENCOURAGING DISCUSSION OF FAMILY BUILDING PLANS AND PRE CONCEPTION FAMILY PLANNING COUNSELING WITH ALL INDIVIDUALS, AS PART OF UNITED STATES PREVENTIVE SERVICES TASK FORCE RECOMMENDED ROUTINE HEALTH MAINTENANCE

# AMA-YPS Internal Operating Procedures (IOP)

The AMA-YPS IOP Committee will study and report back at the 2022 Interim Meeting with further recommendations regarding changes to the IOP.

In accordance with the AMA-YPS IOP, the next review will take place in 2022. The Ad Hoc Committee on the YPS IOP convened in March 2022 to review and prepare recommendations.

With the adoption Report B-I-22, the timeline for the YPS IOP review cycle has been revised accordingly:

- October December 2022: Ad Hoc Committee to prepare IOP memo and preliminary report of the Ad Hoc Committee for the YPS Governing Council review.
- February 2023: YPS Governing Council to present IOP memo and preliminary report to the Council on Constitution and Bylaws and the AMA Board of Trustees.
- May 2023: YPS Governing Council to present final report of the Ad Hoc Committee and draft IOP to the YPS Assembly for comment during the YPS online forum.
- June 2023: YPS Assembly will have an opportunity to ratify the YPS IOP.
