4. Sponsor's Narrative Statement

I first met Alec as a Team Member on the Clinical Problem Solvers Anti-Racism in Medicine Podcast in 2021. He is now the Associate Director of the Podcast and has recorded, edited, and produced numerous episodes with national thought leaders highlighting the health impacts of structural racism in the United States.

I quickly became familiar with Alec's involvement in the AMA and his steadfast commitment to advancing health equity. I have seen him earn the respect of his peers, even those that disagree with him, all while leading a national medical student organization, managing one of the newest standing committees within the MSS, and regularly being involved with programming and initiatives led by MAS and the Center for Health Equity. His leadership and impact directly led to two dozen medical students becoming active members of the MSS, many of whom are now writing their own resolutions, publishing articles, and more. He is also an active member of his Region and helps members with novel policy resolutions on his own time.

It is abundantly clear that Alec is in organized medicine not for his own interests, but to be a voice for change for the communities he partners with, especially American Indian and Alaska Native communities. I know few medical students as confident and well-spoken as Alec and believe he will be a strong voice for the MSS as a member of the MAS GC. In my opinion, he is incredibly qualified for this opportunity, and I recommend him without reservation.

5. Candidate's Statement of Interest

I have dedicated my life to service. This very much aligns with my values and beliefs as a member of the Pauma Band of Luiseño Indians. Some may know that the word Pauma translates to the "place where there is water." No matter how we carry the water or how much we carry, our community has always worked to advance health and wellness for all. While I had little interest in organized medicine before starting medical school, my time in the AMA has been since an integral part of my training and connected with me with a national network of medical student and physician leaders since I joined in 2019. As I transition back into medical school and finish my PhD, I have learned much about the history of the AMA and the importance of diverse representation in organized medicine. I believe my time in the MSS, as a mentor, committee leader, and liaison, has prepared me to interface between the MSS and MAS on issues of mutual importance and collaboration. It would be an honor to represent the MSS on the MAS GC and strengthen our fractured relationships in the House. If you choose me for this position, you will get my full commitment and the benefit of my existing relationships with the MAS as a leader in the Association of Native American Medical Students and member of their Advocacy and Engagement Committees.


