Committee Charter | Updated January 2025

### Purpose

The purpose of the AMA MSS Committee on Civil Rights is to consider the legal jurisprudence and feasibility of policy issues taken up by the MSS, including implications of federal policy and AMA advocacy on local, state, territorial, and tribal governments. It may also include government entitlement programs including but not limited to Medicare, Medicaid, Tricare, the VA, and CHIP. This Committee shall interface with the AMA Council on Legislation (COL), the student representative to the American Medical Political Action Committee (AMPAC), and the Governmental Relations and Advocacy Fellow (GRAF).

#### Structure

 The standing committee structure will undergo a thorough review every four years through a Standing Committee Task Force to determine if it needs to be restructured. Although the Standing Committees will remain for a four-year time period, there is flexibility to add subcommittees as determined by the MSS Governing Council.

  - Produce "whereas" clauses to facilitate the transfer of any adopted report and, if applicable, to MSS-sponsored resolutions submitted to the AMA House of Delegates
- Host biannual resolution onboarding led by appropriate Standing Committee leadership to ensure Standing Committee members are all adequately trained to review resolutions
- Monitor federal legislation, regulation, and litigation relating to their subject area and work with other MSS members and the MSS Governing Council to organize student-led advocacy efforts and request actions by AMA staff as appropriate
- Organize educational programming and advocacy initiatives as necessary and appropriate
- Author comments for AMA Council reports as directed by the MSS Section Delegates

- Support the MSS Governing Council in tracking and publicizing outcomes and implementation of MSS authored items at the AMA House of Delegates in the Standing Committee area of expertise
- Work with AMA staff and the MSS Governing Council to review submissions for the Poster Showcase at the AMA annual and interim meetings
- Work with AMA staff and the MSS Governing Council to review and judge submissions for the AMA research challenge

The Committee on Science and Technology shall be led by one (1) Chair and three (3) Vice Chairs named by the MSS Governing Council. Additional leadership shall be appointed by the Committee Chairs as deemed necessary. The review and recall system shall follow <u>Uniform Process for Leadership and Membership Recall Decisions</u>.

The Chair shall be responsible for overall leadership, strategic direction, and oversight of the committee's activities. Each Vice Chair shall be focused on a specific domain to divide responsibilities and ensure efficient workflow. Specific domains will include:

- Reports: Oversees research, report writing, and any data-driven initiatives or committee deliverables
- Programming: Handles planning and execution of committee events, educational programming, and engagement initiatives
- Resolutions: Leads the development, drafting, and advocacy of committee resolutions and policy proposals

# Membership

The Committee on Science and Technology shall be composed of members from the MSS, with no minimum or maximum number of members. The members shall serve a one-year term if chosen after the MSS Annual Meeting. The members shall serve a six-month term if chosen after the MSS Interim Meeting. Committee members appointments and recall decisions shall adhere to the Uniform Process for Leadership and Membership Recall Decisions.

# Meetings

The Committee on Science and Technology will meet at least once per policy cycle and more often as determined by committee leadership. A majority of the committee members shall constitute a quorum. The Standing Committee Task Force will review charters quadrennially to update charters as appropriate.
