

Initial Report of the Resolutions Committee
November 2021 Special Meeting

The handbook and addendum contain 136 resolutions that have been proffered for the November 2021 Special Meeting of the House of Delegates. The Resolutions Committee has determined that the 28 resolutions listed below meet the priority threshold and should be accepted as business at the meeting.

This initial recommendation is based, in part, on the amount of business considered at the last two Special Meetings, both of which extended well into the afternoon of the last day:

- November 2020 - 44 reports and 36 resolutions (out of 99 submitted)
- June 2021 - 51 reports and 64 resolutions (out of 150 submitted)

No conclusion should be drawn about the remaining resolutions as additional resolutions will be recommended for acceptance in the final report. Those additional resolutions will come from items yet to be submitted as well as from among the remaining 108 already distributed.

The Committee will consider available information and issue its second report on November 8, and the House will vote on the Committee's recommendations during the opening session on Friday, November 12.
