

# Call for Candidates for AMA Nomination for the ACGME Review Committee for Obstetrics & Gynecology

The AMA is soliciting AMA member candidates for nomination by the AMA Board of Trustees for a position on the **Accreditation Council for Graduate Medical Education Review Committee for Obstetrics & Gynecology** (ACGME RC-OBG).

# **TERM**

The term of the position is 6 years, from July 1, 2025, through June 30, 2031.

# TIME REQUIREMENT

Nominees must be able to devote sufficient time to the Review Committee's work. The Review Committee meets three times per year, usually during the months of February, April and September. The duration of the February meeting is 3 days; April and September meetings run for 2 days. While meetings are currently hybrid, in-person attendance is strongly encouraged. Time devoted to the Review Committee includes an estimated 35 hours for program review assignments prior to each meeting (up to 10 full reviews per meeting), subcommittee work (as assigned), prep time for each Review Committee meeting to review agenda items and related documents, and travel/attendance for each Review Committee meeting. # CRITERIA FOR AMA NOMINATION TO ACGME RC-OBG

# **ACGME RC-OBG Requirements for this Opportunity**

1. Nominees must be currently certified in obstetrics and gynecology by the American Board of Obstetrics and Gynecology or the American Osteopathic Board of Obstetrics and Gynecology.

Nominees must practice and have certification in Female Pelvic Medicine and Reconstructive Surgery (Urogynecology and Reconstructive Pelvic Surgery).

Nominees must be female pelvic medicine and reconstructive surgery (urogynecology and reconstructive pelvic surgery) fellowship program directors or have recently held this position.

- 2. The Review Committee can have up to two members from the same state, but they cannot be from the same institution or city/metropolitan area. Accordingly, individuals must not be nominated from the following institutions and areas:
  - Saint Joseph Hospital, Intermountain Health Denver, CO
  - University of Hawaii John A. Burns School of Medicine Honolulu, HI
  - Rush University Medical Center Chicago, IL
  - Ascension St. Vincent's Hospital Indianapolis, IN
  - University of Maryland School of Medicine Baltimore, MD
  - Henry Ford Macomb Hospital/Henry Ford Medical Group Clinton Township, MI
  - Cape Fear Valley Medical Center Fayetteville, NC
  - Maimonides Medical Center New York, NY
  - State of Texas
  - University of Washington Seattle, WA
- 3. Nominees must demonstrate national leadership in obstetrics and gynecology.
- 4. To increase diversity, the Review Committee will give preference to candidates from populations underrepresented in medicine.
- 5. Nominees' programs must have a status of Initial Accreditation, Continued Accreditation, or Continued Accreditation without Outcomes.
- 6. Nominees must be able to devote sufficient time to the Review Committee's work. The Review Committee meets three times per year, usually during the months of February, April and September. The duration of the February meeting is 3 days; April and September meetings run for 2 days. While meetings are currently hybrid, in-person attendance is strongly encouraged. Time devoted to the Review Committee includes an estimated 35 hours for program review assignments prior to each meeting (up to 10 full reviews per meeting), subcommittee work (as assigned), prep time for each Review Committee meeting to review agenda items and related documents, and travel/attendance for each Review Committee meeting. Review Committee members must attend all Review Committee meetings.
- 7. Nominees must be skilled in the use of computers. Review Committee members must use electronic systems for most accreditation activities and reimbursement of expenses.

### **AMA Requirements**

Each nominee recommended by the AMA must be a member of the AMA at the time of nomination. If appointed, he/she must maintain AMA member status throughout the term of appointment. AMA membership does not guarantee a position. - 3. Current full curriculum vitae.
- 4. Optional: Up to two letters of recommendation, addressed to the AMA.
