

State-Developed Medicaid Work Requirement Resources

Last updated Sept. 8, 2026

Beginning January 1, 2027, certain adults enrolled in Medicaid will be required to demonstrate that they are working or participating in other qualifying activities to obtain or maintain coverage, unless they qualify for an exclusion or exception. States are developing websites, frequently asked questions, screening tools, member notices and other materials to help Medicaid applicants and enrollees understand and comply with these new requirements. The scope and level of detail of these resources vary considerably. Some states have developed comprehensive member websites, screening tools and multilingual materials, while others have published only preliminary information.

The AMA Advocacy Resource Center (ARC) has compiled the state-developed resources below to help state medical associations and national medical specialty societies monitor how states are communicating with Medicaid applicants and enrollees, compare approaches to member education and outreach across states, and assist physicians and others in directing patients to reliable information. This tracking information focuses on official, publicly available state resources intended for Medicaid applicants, enrollees or those assisting them. The ARC will update this page as states release new or revised materials.

These states are not included in this resource. Georgia and Wisconsin have not adopted full Medicaid expansion but are included in this resource because they cover certain adults through Section 1115 demonstration programs to which work requirements apply.
