This enhancement introduces two new data elements, Controlled Substance Registration (CSR) and System for Award Management (SAM) Exclusions. These new elements will provide you with even more valuable information in the credentialing processes.

Let's explore the two new data elements that will bring these benefits to your organization:

### New features and updates

#### 1. Controlled Substance Registration

##### What is it?

The state Controlled Substance Registration (CSR) is required in some states for healthcare professionals who prescribe, administer, order or store controlled substances.

- Confirm state-issued CSR registration details for physicians
- Meet accreditation requirements

##### Key data elements provided:

- CSR Number (masked to protect against fraud)

## AMA VeriCre™ Profile

CSR has a dedicated section in the VeriCre™ profile for physicians with active registrations.

### Current controlled substance registration or controlled dangerous substance information

*Many, but not all, states and US territories require physicians to obtain a state-specific registration or license for controlled substances. The VeriCre Physician Profile displays current registrations and licenses from those states and US territories that report to AMA.*

## 2. System for Award Management (SAM) Exclusions

### What is it?

SAM is a federal database that monitors agency debarments, including those from the Office of Inspector General (OIG). SAM exclusions identify parties barred from receiving federal contracts, financial assistance, and other benefits.

- Quickly identify and monitor federal agency debarment sanctions for physicians
- Meet accreditation requirements

### Key features

- Daily status checks: Data indicates if a physician has an active sanction based on the day an application is submitted or a VeriCre™ profile is ordered
- Seamless integration: While not populated directly to the application, this information is readily available in MA Passport via the Verification Log screen
