#### 4. Sponsor's Narrative Statement

It is my distinct pleasure to sponsor Minali Prasad for the AMA WPS GC MSS Representative position. For seven years, we collaborated in a variety of contexts, including academics, extracurriculars, clinical rotations, and organized medicine, so I am confident that she is extremely well-suited to serve a second term on the GC. While excelling in a demanding research fellowship at the NIH, she continues to engage in extensive community work with underserved women in the local South Boston community. She remotely organizes monthly student-led vision screening sessions at local homeless shelters including the Woods-Mullen women's shelter. She teaches college and medical students how to conduct these screenings, provide hospital and MassHealth registration information, and disseminate at-home remedies for eye irritation in efforts to improve access to ophthalmic care. This is also her second year of teaching English to Syrian and Ukrainian refugees as well as unhoused women at Rosie's Place. Moreover, she continues to provide mentorship to female high school and pre-medical students from disadvantaged backgrounds through local and national organizations including the Association of Women Surgeons, the BUCASM Mentoring for Aspiring Physicians, the BUCASM Science Teaching Enrichment Program, and the Underrepresented in Medicine Ophthalmology Mentorship Program. These numerous community service efforts are recognized by the Massachusetts Medical Society through her elected position as the Community Service Chair of the Medical Student Section Governing Council. The depth of her community work underscores her commitment to addressing health disparities both in her community and abroad, particularly those that affect underserved women.

## 5. Candidate's Statement of Interest

Since June, I had the privilege of collaborating with AMA WPS GC members to achieve the objectives outlined in our Strategic Plan. Notably, I organized a virtual WPS member panel to share their professional journeys and insights, advocated for the Giambalvo Fund awardee, and participated in the WPS HOD Handbook review. Through these experiences, I found that my niche within the WPS is improving awareness of women's health issues and advancing career development for WIM. I would appreciate the opportunity to further immerse myself in WPS by spearheading new initiatives for these objectives, such as developing engaging and informative infographics for our monthly newsletter and organizing expert WPS speaker panels for each women's health month, as well as hosting virtual lunch talks to spotlight WPS member research and advocacy work.

In addition, I also plan to continue collaborating with WPS members on objectives involving policy, leadership development, and advocacy. Attendance at I-23, membership in the A-23 MSS Caucus, and participation in the WPS HOD Handbook review granted me thorough exposure to the grassroots policymaking process from initial resolution writing and editing to final review. During my second term, I will apply this new skillset to assume a more active role in the policymaking process by writing policies pertinent to the WPS mission, including reducing health disparities, discrimination, and barriers to healthcare. WPS is an inspiring group of physician activists, and I would be honored to return for a second term to help fulfill its objectives.



It is my distinct pleasure to recommend Minali Prasad for re-appointment to the AMA Women Physicians Section Governing Council as the Medical Student Section Representative. I am the Vice-Chairman of Faculty Affairs and an Associate Professor in the Department of Ophthalmology at the Boston University Chobanian & Avedisian School of Medicine. I also serve on the Gender Equity Advisory Council of Boston University Medical Center. Since her last semester of college, I have mentored Minali in several contexts, including the majority of her research projects, her ophthalmology clinical rotation, and in community service activities.

Throughout our time together, Minali has consistently expressed an interest in examining health disparities affecting underserved populations. For example, she cofounded a student organization, Boston Sight Savers, that hosts free vision screenings at homeless shelters in South Boston, including women's shelters. While working remotely for her research fellowship at the National Institutes of Health, she continues to organize monthly sessions through regular communication with the on-site shelter directors. More recently, she spearheaded a research project investigating the association between central serous chorioretinopathy and socioeconomic determinants of health. She single-handedly led project administration, displaying exceptional verbal and written communication skills to guide a team of four college and medical students in data collection and statistical analysis. Beyond her excellent teamwork and leadership skills, she has demonstrated efficient time management by balancing her position on the WPS GC with a full-time research fellowship, board studying, volunteering, and numerous research projects with me. Despite her busy schedule, she continues to display persistence and motivation in producing high-quality work in all her pursuits. I enjoy learning about her work on the WPS GC, and I am confident that given her research and community service background, she will make a lasting impact in advancing the council's mission during her second term.

Minali's intention to serve on the WPS GC is driven by her pursuit to improve health disparities and advance the professional development of women in medicine. Her thoughtful approach, professionalism, research focus on health disparities, and teamwork skills position her well for success on the AMA WPS GC.
