Watching my grandparents and family friends struggle to navigate the healthcare system and get the care they needed inspired my decision to go into medicine, but I knew I wanted to do more than simply practice compassionate care. I realized that to improve our medical landscape, I would need to get involved with policy-making and administrative roles. My interests became aligned with women's health while working with breast cancer survivors and domestic violence survivors in the upstate of South Carolina during college. Hearing their personal experiences made me realize how much work there is to be done, and I would love to directly work towards better access to care and gender equity through WPS. I hope you consider me for the medical student representative role, as I would be honored to take on this responsibility.


7. Candidate's Diversity Statement. Please describe how you will bring diversity to the position for which you are applying.

Having served on multiple DEI committees while in college, I developed an understanding of the importance of fostering inclusivity. These experiences equipped me with the skills to advocate for diversity, equity, and inclusion within my immediate community, and they will help me achieve similar goals in the medical community. My ongoing research in breast cancer care disparities reflects my commitment to addressing systemic issues affecting women's health, particularly those from underrepresented backgrounds.

I currently serve on the executive board of UVA's Health Policy Interest Group, where I actively introduce and educate my fellow students on relevant policies promoting equitable healthcare. This position and my involvement in other leadership and student government positions further demonstrate my ability to collaborate, lead, and implement positive change.
